**BEING SEISED** of Case File No. 002/19-09-2007/ECCC/TC pursuant to the Decision on KHIEU Samphan's Appeal against the Closing Order (PTC), D427/4/15, 21 January 2011; the Decision on Appeals by NUON Chea and IENG Thirith Against the Closing Order (PTC), D427/2/15 & D427/3/15, 15 February 2011; and the Decision on IENG Sary's Appeal against the Closing Order (PTC), D427/1/30, 11 April 2011;

**RECALLING** the Trial Chamber Decision on Additional Severance of Case 002 and Scope of Case 002/02, E301/9/1, 4 April 2014 as well as the Trial Chamber's Workplan for Case 002/02, E301/5.1, 24 December 2014;

**HAVING RECEIVED** the Parties' updated materials in preparation for trial in Case 002/02, including an indication of the legal issues they intend to raise at the Initial Hearing;<sup>1</sup>

#### **HEREBY**

**NOTIFIES** the Parties that pursuant to Internal Rule 81*bis* a further Initial Hearing for Case 002/02 concerning the Accused NUON Chea and KHIEU Samphan will be held on **Wednesday**, 30 July 2014 in the main courtroom of the ECCC at 9:00 am. If necessary, the hearing will continue on Thursday, 31 July 2014;

At the hearing, the Chamber will consider the following issues:

- Further Specification of Civil Party Reparation Awards;
- Status of Preliminary Objections and Review of Legal Issues Relevant to Case 002/02; and
- Sequencing of the Trial proceedings and Initial Review of Potential Witnesses, Civil Parties and Experts.

Only the KHIEU Samphan Defence has filed an indication of the legal issues it intends to raise at the hearing. *See* Indication des points de droit que la Défense de M. KHIEU Samphân entend soulever lors de l'audience initiale du procès 002/02, E305/11, 9 June 2014.

The hearing will be held in public, unless discussion on potential witnesses, Civil Parties and experts warrants the holding of some portions of the hearing in closed session. Any closed session will be held at the end of the hearing.

The Chamber will not hear oral argument during the hearing in relation to any issue other than those indicated above. Comments on the above agenda should be sent to the Chamber by e-mail via the Trial Chamber Legal Officer, copying all other parties, by 19 June 2014. A detailed Agenda for the Hearing will be issued in due course, in advance of the Hearing.
