SUBMISSION

- 1. Pursuant to Internal Rule 80(3) and in accordance with the Trial Chamber's "Order to File Updated Material in Preparation for Trial in Case 002/02" issued on 8 April 2014 ("Order"), as amended by the "Decision on the Joint Request regarding Refiling of Admitted Evidence in Case 002/03, and Filing in One Language" of 21 May 2014 ("Decision"), the Co-Prosecutors submit this updated list of documents already admitted as evidence before the Chamber, together with new documents they intend to put forward during trial proceedings in Case 002/02 ("Trial Document List").
- 2. The documents in the Trial Document List are identified in 23 separate Annexes comprising three groups, **Annexes 1A** to **20A**, **B** and **C1** and **C2**.
- 3. **Annexes 1A** to **20A** comprise 6 489 documents included on the Co-Prosecutors previous Rule 80 Document List filed in April 2011 ("Initial R80 List"),³ and follow the same logic and structure, with one Annex per document type or related types.⁴ Document descriptions and the most relevant, non-exhaustive points of the Indictment have been updated based on the scope of trial in Case 002/02. The different legal status of the documents in the Annexes have been identified in three ways, with (a) grey highlighting, (b) blue highlighting and (c) no highlighting:
 - (a) 169 documents bearing **grey highlighting** with text struck through are being withdrawn from the Co-Prosecutors' document list;

- (b) 4 774 documents bearing **blue highlighting** *without* text struck through have already been placed before the Chamber from Case 002/01 and previously admitted; 13 documents *with* text struck through are duplicate entries from the Initial R80 List which have already been admitted by the Chamber; and
- (c) 1 546 documents bearing **no highlighting** have already been proposed in the Co-Prosecutors' Initial R80 List and continue to be proposed as documents to be put before the Chamber in Case 002/02.
- 4. **Annex B** comprises 184 documents not included in the Co-Prosecutors' Initial R80 List, but were subsequently put before the Chamber and admitted in Case 002/01 as new evidence under Internal Rule 87(4).
- 5. **Annexes C1** and **C2** comprise 856 documents not previously put forward, which the Co-Prosecutors intend to be put before the Chamber in Case 002/02. Of these, the 383 documents in **Annex C1** are already part of the Case File. The remaining 473 documents in **Annex C2** are not yet included in the Case File, have already been assigned Evidence Reference Numbers (ERN) in most cases and will be placed on the Shared Materials Drive for review by the Parties and the Chamber.
- 6. In accordance with the terms of the Order,⁵ the Annexes consist of tables that include the following document details: (1) the E3 admitted evidence number from the 002/01trial; (2) any other case file document number; (3) the type or category of the document (where more than one category is included in an Annex); (4) the author of the document (where appropriate); (5) the date of the document; (6) the title of the document; (7) the evidence reference number ("ERN") for the Khmer, English and French version of the document whether the original or a translation (where available); (8) a description of the document; and (9) the most relevant, non-exhaustive points of the Indictment which the document assists in proving.
- 7. The documents within **Annexes 1A** to **20A** are ordered chronologically or alphabetically, as most appropriate to assist the Chamber and other parties in locating the documents and understanding their relevance. **Annexes B, C1** and **C2** are ordered by type then date of

document. As directed by the Chamber, the Co-Prosecutors will provide Microsoft Word versions of the Annexes to the Chamber's Greffiers for internal use.⁶

- 8. The Co-Prosecutors have excluded from their current Trial Document List 267 statements by witnesses and Civil Parties in Cases 003 and 004, whose evidence has come to the attention of the Co-Prosecutors solely through interviews conducted by the Co-Investigating Judges, and which are presently classified as confidential within those Case Files. The International Co-Prosecutor duly filed requests to the International Co-Investigating Judge to disclose these interviews to the Chamber and the Parties in Case 002/02.
- 9. On 8 May 2014, the International Co-Investigating Judge denied these requests "at this stage" but "remained seized" thereof,⁷ finding that, for the time being, such disclosure "could potentially endanger the investigation" in each case.⁸ The International Co-Investigating Judge noted that "no fixed date has been set for the commencement of trial in Case 002/02," and confirmed that "Once the International CIJ deems that disclosure of the documents is no longer capable of jeopardising the investigation, he will authorise the [International Co-Prosecutor] to seek their admission in Case 002/02" and "will inform the Co-Prosecutors as soon as it becomes prudent to oblige the Request." Once a trial date is set, the International Co-Prosecutor undertakes to immediately notify the International Co-Investigating Judge and to reiterate his request for disclosure.
- 10. Only English copies of Annexes to this Submission have been provided, as it is not possible to complete the translations of them within the required time limits, even with the full use of internal language capabilities. 12 Accordingly, as authorised by the
