#### **Summary of Proceedings**

#### Opening of hearing and report on attendance of the Parties

The President opened the proceedings and the Greffier informed the Chamber that all parties were present, except for the Accused NOUN Chea who was in the holding cell.

#### NUON Chea request to follow the hearing from the holding cell

The Trial Chamber granted the request of the NUON Chea Defence Team for NUON Chea to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

#### Privacy concerns in regard to witnesses

The International Co-Prosecutor inquired whether WESU specifically advises witnesses about the possibility of special measures, including closed session, due to the nature of the alleged offences. The Trial Chamber noted that it will verify with WESU whether specific

advice is given to witnesses and concluded that should a witness raise specific concerns during the hearing, the Chamber will rule on them.

#### Questioning of Witness CHANG Sreymom (2-TCW-834)

The Trial Chamber and Parties commenced the questioning of the Witness, with her testimony to continue on Monday 2 February 2015.

#### NUON Chea request for guidance on objections

The NUON Chea Defence again objected to the use of term "the Khmer Rouge" and to use of documents pertaining to Kraing Ta Chan Security Centre. The NUON Chea Defence sought guidance from the Trial Chamber on whether it should object each time this term and these documents are used. The Chamber declined to make a general ruling and reminded counsel that they do not need to repeat objections the Chamber has already ruled upon unless additional grounds are identified.
