Summary of Proceedings

Opening of hearing and report on attendance of Parties

The President opened the proceedings and the Greffier informed the Trial Chamber that all parties were present except for KHIEU Samphan Defence Counsel Mr. Arthur VERCKEN and Civil Party Lead Co-Lawyer Mr. PICH Ang. The Accused NUON Chea was present in the holding cell.

NUON Chea request to follow the hearing from the holding cell

The Trial Chamber granted the request of the NUON Chea Defence Team for NUON Chea to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

Questioning of Civil Party SORY Sen (2-TCCP-271)

NUON Chea Defence continued with the questioning of the Civil Party 2-TCCP-271, followed by the KHIEU Samphan Defence.

Concerns of privacy of victims of sexual crimes

The Civil Party Lead Co-Lawyer raised an issue of privacy of victims of sexual violence in a public trial. The Trial Chamber advised the Parties, who wished to publicly identify a victims of sexual violence, to pass the name on a piece of paper for identification and if this would lead to more questions, the Chamber would consider a closed session.
