#### Summary of Proceedings

#### **Opening of the Substantive Hearing**

The President informed the Parties of the absence of Judge YOU Ottara, who was substituted by Judge THOU Mony. The Greffier informed the Chamber that all parties are present. NUON Chea was present from his holding cell.

#### NUON Chea waiver to be present at the Courtroom

The President informed the Parties of NUON Chea's request to follow the proceedings from the holding cell and the waiver of his right to follow the proceedings from the courtroom. The Trial Chamber granted the request.

### Use of document not in the Case File

The International Co-Prosecutor objected to the questioning of NUON Chea Defence based on a document not in the Case File. The Civil Party Lead Co-Lawyer joined the objection. The Trial Chamber reminded the parties that only documents on Case File can be used during the hearings and that a party must submit a rule 87(4) request when introducing documents which are not in the Case File. However, the Trial Chamber exceptionally allowed the NUON Chea Defence to submit these documents on shared drive within 48 hours, accompanied by a Rule 87(4) request. The Chamber concluded that the Civil Party will be recalled for questions based on those documents if necessary.

#### Testimony of Civil Party OM Suphany (2-TCCP-296)

The NUON Chea Defence continued with the questioning of the Civil Party 2-TCCP-296, followed by questioning from KHIEU Samphan Defence. The Civil Party made a statement on the impact of the crimes and poses question to the Accused through the Trial Chamber. The Accused exercise their right to remain silent. Testimony of Civil Party OM Suphany (2-TCCP-296) is concluded.

#### Testimony of Civil Party CHOU Koemlan (2-TCCP-238)

The Trial Chamber, Civil Party Lead Co-Lawyer and Co-Prosecutors posed questions to the Civil Party.

#### New Statements proposed by the OCP

The NUON Chea Defence requested clarifications from the Office of the Co-Prosecutors in regard to the disclosure of statements from Case File 004 relevant to the Case 002/02 (E319/8).

#### Adjournment and changing of the sitting schedule

The Trial Chamber informed the parties that it will adjourn due to ill health of the Accused KHIEU Samphan. The Trial Chamber informed the Parties that from 27 January 2015 onwards, the morning sessions will be from 09:00 am – 11.30 am, in order to grant the Accused KHIEU Sampan more time to rest. The afternoon sessions remain unchanged.
