Summary of Proceedings

Opening of the Substantive Hearing

The President opened the proceedings. The Greffier informed the Chamber that all parties are present except for the accused NUON Chea. NUON Chea is present in the holding cell.

NUON Chea request to follow the hearing from the holding cell

The President informed the Parties of NUON Chea's request to follow the proceedings from the holding cell and the waiver of his right to follow the proceedings from the courtroom. The Trial Chamber granted the request pursuant internal rule 81.5.

Observations regarding the introduction of statements from Case 004 in the case file of Case 002/02

The NUON Chea and KHIEU Samphan's Defence teams raised concerns about the ongoing and continuing disclosure of statements from Case 004 in case file 002/02. The Co-Prosecutor indicated that he will inform the Chamber as soon as possible about the total number of the statements for which disclosure is sought. During the afternoon session, the NUON Chea defence made additional remarks about the volume of statements from Case 004 disclosed in Case 002/02. Accordingly, the NUON Chea defence requested a postponement of the proceedings to review these statements. The KHIEU Samphan Defence supported the request by the NUON Chea Defence, adding remarks about the repetitive character of some of the statements. The Co-Prosecutor and Civil Parties Lead Co-Lawyer objected to the Defence request. The Trial Chamber will consider the issue in due course.

Questioning of witness EM Phoeung (2-TCW-954)

The Co-Prosecutor started the questioning of Witness EM Phoeung (2-TCW-954) followed by Civil Party Lead Co-Lawyer, NUON Chea Defence and KHIEU Samphan Defence. The testimony of the witness has been completed.

Questioning of Witness PHNEU Yav (2-TCW-934)

Trial Chamber started the questioning of Witness PHNEU Yav (2-TCW-934). The witness has taken an oath and has no relations with other parties in the trial. The President informed the witness about his rights and duties.
