Summary of Proceedings

Opening of the Substantive Hearing

The President opened the proceedings and the Greffier informed the Chamber that all parties were present except for the Accused NOUN Chea and Mr. Arthur VERCKEN (International Co-Counsel for KHIEU Samphan). NUON Chea following the proceedings from the holding cell.

NUON Chea request to follow the hearing from the holding cell

The President informed the Parties of NUON Chea's request to follow the proceedings from the holding cell and waiver of right to follow the proceedings from the courtroom. The Trial Chamber granted the request pursuant Internal Rule 81.5.

Questioning of Witness CHEANG Sreimom (2-TCW-834)

NOUN Chea Defence commenced the questioning of Witness CHEANG Sreimom (2-TCW-834) followed by KHIEU Samphan Defence.

Questioning of Witness KEO Chandara (2-TCW-964)

The Co-Prosecutor questioned the Witness, followed by the Civil Party Lead Co-Lawyer, NOUN Chea Defence and KHIEU Samphan Defence.

Trial Chamber Oral Ruling

The Trial Chamber issued an oral ruling on the request by the NUON Chea Defence for the reconsideration of certain practices for the examination of witnesses and Civil Parties in particular, on: (i) the practice of permitting witnesses to review prior statements before testifying and then to answer questions based on those statements; (ii) the undue restriction of the scope of Defence cross-examination; and (iii) the undue heavy reliance on Civil Party testimony. The Trial Chamber rejected the NUON Chea Request with written reasons to follow.
