Summary of Proceedings

Opening of hearing and report on attendance of Parties

The President opened the proceedings and the Greffier informed the Trial Chamber that all parties were present except for the Accused NUON Chea. NUON Chea was present in the holding cell.

NUON Chea request to follow the hearing from the holding cell

The Trial Chamber granted the request of the NUON Chea Defence Team for NUON Chea to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

Questioning of Witness Srei Than alias Duch (2-TCW-944)

The KHIEU Samphan Defence posed questions to Witness Srei Than alias Duch (2-TCW-944). Duty Counsel for Witness 2-TCW-944 was present in the courtroom. The testimony of the Witness was concluded.

Request for forensic analysis

KHIEU Samphan requested the Trial Chamber to order a forensic analysis of a signature in document E3/2107. The Chamber also instructed the KHIEU Samphan Defence to submit a written request citing legal grounds and the purpose of the forensic analysis.

List of documents and observations on the use of interface

The Lead Co-Lawyers notified the Trial Chamber that they had not received the list of documents intended to use during the questioning of the following witness from NUON Chea Defence and reiterated the need for clarifications on the use of interface. The Trial Chamber notified the parties that guidance in regard to use of the interface is being prepared.

Trial scheduling in light of a new disclosure

The Trial Chamber notified the parties that it will continue the hearing of the following witness during the whole next day, followed by an adjournment of hearings in order to allow the parties to have sufficient time to review the newly disclosed documents. The hearings will resume on the afternoon of the 3 March 2015.
