Chea Defence questioned the Witness VORNG Sarun (2-TCW-986). The Civil Party Lead Co-Lawyers ceded their time for questioning the Witness to the Co-Prosecutors.

# NUON Chea Defence request to question Witness VONG Sarun (2-TCW-986) after all other Parties

Due to the absence of NUON Chea Co-Lawyer Victor Koppe in the morning, the NUON Chea Defence requested to hear the Witness in the afternoon, after all other Parties. The KHIEU Samphan Defence agreed to question the Witness before the NUON Chea Defence and the Trial Chamber granted NUON Chea Defence's request.

# Co-Prosecutor's request to place a certain document before Witness VONG Sarun (2-TCW-986)

The Co-Prosecutors requested to refer to a document relating to the notes from the interrogation of Witness VONG Sarun (2-TCW-286) at Kraing Ta Chan Security Centre. The Trial Chamber inquired for what purposes the Co-Prosecutors intended to put the document before the Witness, considering that it may be torture-tainted evidence. The Co-Prosecutors stated it served no other purpose than to refresh the Witness' memory and the Trial Chamber subsequently granted the request.
