Summary of Proceedings

Opening of hearing and report on attendance of Parties

The President opened the proceedings and the Greffier informed the Trial Chamber that all Parties were present. The Accused NUON Chea was present in the holding cell.

NUON Chea request to follow the hearing from the holding cell

The Trial Chamber granted the request of the NUON Chea Defence Team for NUON Chea to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

Questioning of Witness Richard DUDMAN (2-TCW-923) via videoconference

The NUON Chea Defence, Co-Prosecutors and Lead Co-Lawyers questioned the Witness Richard DUDMAN (2-TCW-923) by videoconference.

Trial Chamber decision on Co-Prosecutors' request E342

The Trial Chamber instructed the Co-Prosecutors to specify the excerpts of the document it seeks to to be admitted into evidence, in lieu of the entire book.

NUON Chea request to cross-examine civil parties appearing for the Hearing on Harm suffered by Civil Parties

The NUON Chea Defence requested the Trial Chamber to have equal time to question each civil party appearing during the Hearing on Harm if the statements on suffering introduce new facts of allegations against the Accused. KHIEU Samphan also requested clarification on whether the civil parties can be questioned on purely factual issues.

Discussion on Lead Co-Lawyers proposed time allocations for hearing Civil Parties

The Lead Co-Lawyers, NUON Chea Defence, KHIEU Samphan Defence, Co-Prosecutors and Trial Chamber discussed the Civil Party Lead Co-Lawyers proposed schedule for the hearing on civil party suffering, contained in E315/1/1.1.
