- 4. Kuch (កុច) (Division Logistics stationed in Kampong Thom (កំពង់ធំ)) (not yet detained)
- 5. Hâm (th), Regiment, not yet detained. After the whole country was liberated, he was induced by Hoh (time) using their long-time friendship.

(I would like to mention only the core people above, while the following people were also built, but I cannot recall their names) About the project of new direction: it was agreed that it should be continued but mainly a strong base must be built. This issue was dependent upon comrade Soth (hg), who was the most effective person. Comrade Soth interrupted that he could not be responsible for this movement alone. Experience from Chhouk (hg) showed that despite their long-time connection, they still could not escape that. So, it should not be done immediately. It needed more time while we were in good connection. The discussion became deadlocked, so we all took a break and retreated to our respective places.

Later on, we met again at the same place. This time we discussed arrangement of connections and plans for 1977.

Because there was no more leading apparatus, our continuous duties were following:

- It was easy for me (Doeun (智麗)) and comrade Soth. Legally, comrade Soth would be in charge of a Sector independently, while comrade Srēng was not independent. So, on the one hand, his entry and departure were not so appropriate that it would be compromised and the Centre might get suspicious. On the other hand, comrade Srēng could also contact comrade Soth.

# I would like to report more traitorous activities adding clarification to the previous report

### Chor Chhan alias Sreng

After I received the instruction from Thuch (भूछ) to betray *Angkar* and to become CIA agent in 1965, I have conducted the following activities:

- In 1965, besides meeting with HÀNG Thun Hǎk (讥诮 瞬即前), via Thuch, I also contacted the governor of Prey Chhor (背頂瓜珠) district named SÂ Hok (允 叭节), the younger brother of A SÂ Hao (允 いい). At the first contact, they were just friends who studied at the same school as SÂ Hok's son/daughter. (SÂ Hao got drunk every day and lived a comfortable life.)
- In 1963-64, the revolutionary movement in Prey Chhor District was very active; there were movements to conduct meetings, prepare petitions, conduct rebellion against the cruel teachers at school and conduct demonstration against the Vietnamese aggression (1964).
- Encourage to organize a Progressive organization among the masses such as: the Youth Friend (ឬវិមិត្ត) newspaper reading groups, Progressive book reading teams, (Chinese) Progressive magazines etc. In the rural areas, the encouragement of democratic resistance was also very active: encourage to pay no taxes, demand land in Teuk Chha (ទីកីឆា), Beong Chhouk (ប៊ីដំណូត), demand A Kâ Khum (អាករឃុំ) lake, which they schemed to let merchants and land lords do, and organize various Progressive communities and organizations such as medical associations, rice storehouse for rescue, midwife association etc.

... there was clearly a new force coming to lead. So, it would make us lose benefit. Now, we would suggest you, comrade, to keep silent and try to assemble and command the remaining force. It would better to arrange forces in jungle in order to show the mass that we were still conducting revolution. This way, the mass still continued their trust on us. And in the future, we would still remain the core of our movement.

About the security issue: when we infiltrated within the local base or jungle, we contacted them and told them not to invade. Thuch said that he had already told the above-mentioned people. And there were still more forces in the base that we could induce. Our activities should not be exposed. We talked with them only about the conduct of revolution. That was the exact forces that could not stand the enemy and wanted to join our cause.

In August 1968, I decided to live in the jungle alone and contacted our comrades in the village at night. Sometimes, I stayed in the village. After a while, I encouraged the force to destroy the reactionaries in the village so that they could no longer rise up again.

In September 1968, we successfully destroyed the reactionary, namely A PRĂK Un (ប្រាក់ អ៊ុន) in Nam Ken (ណាំកិន) village, approximately 1 kilometre south of the town in Prey Chhor district. Our forces at that time were: me, comrade PRAK Min (ប្រាំមីន), comrade KÈ Hau (ពី ហ្ម), and comrade Tep (ទេព).

Beside the force we assembled in jungle, there was also a village force. Especially at the base there were: comrade Soeun (ហើ្សីន) (current deputy secretary of Sector 41), comrade Chèm (ម៉ែង) (former member of Prev Chhor district, deceased), comrade Sây (MU) and comrade Yean (LNS) (currently in comrade Chhin's (กิริสิ) Division). But comrade Sây's base was invaded by the enemy after the destruction of the reactionary named PRĂK Un.

In 1968, from March 1968 onward, I lost contact with Thuch but still connected with comrade Doeun. It was only until November 1968 that I could meet Thuch at Brother Kep's (ពែប) house (currently diplomat to we arrived we greeted each other as usual. We stayed the night and started to work in the next morning.

At that time, I was reporting about the riot and fight to get weapon at Prey Chhor district hall, the destruction of enemy in Trapeang Bei (ត្រាំងប៊ី), the destruction of A PRĂK Un, the enemy's invasion south of Prey Toteung (ព្រៃទទឹង) after the smashing of A PRĂK Un, the situation of the jungle forces and the forces at a number of bases near Prey Boeng (in បឹង) and the situation of building traitorous forces at that time. To conclude the reporting, I proposed to halt the activities in jungle because there were many difficulties.

At that time comrade PRÅK Min and comrade Tep got injured by their own guns but they were alright. After smashing the reactionary named PRÅK Un, the enemy also started to invade in the base at the south of Prey Toteung and arrested 8 more of us and 2 ordinary people, while my force of 4 people were hiding in jungle as usual.

Because we did not set up any measures for our comrades to withdraw their forces in advance, after the incident of destroying the reactionary, the enemy was able to invade us. I would like to emphasize that comrade PRÀK Min and comrade KÈ Hau sacrificed themselves in January 1969 when they went out to contact the base and were arrested by the enemy. After the arrest of comrade PRÀK Min and comrade KÈ Hau, comrade Tep was also no longer active until now. But in early January 1969 *Angkar* sent:

- Comrade Kēng (ភេង) was former secretary of Kampong Svay (កំពង់ស្វាយ) district, Sector 43.
- 2. Comrade Yuth (tig) was in comrade Chhin's Division. I heard that he was dead of illness.
- 3. Poul (ຖຸດ) was current chairman of the North Zone commerce
- 4. Dân (以) ran back to Phnom Penh after comrade PRÀK Min and comrade KÈ Hau were arrested.
- 5. Srun (ស៊្រុន) was current secretary of Stoung (ស្អោង) district.

They were the remaining forces and continued leading the movement.

... legally easy. If we did so, it would not be easy for other force to take them back. We also worked that way. However, if we allowed the American imperialists to a launch coup d'état to topple the feudalists and establish a republic regime in Cambodia, they could do that militarily and legally. But this matter would clearly benefit the revolutionary movement. This was because the people had hated the American imperialists for a long time. Communist Party clearly analyzed this issue, but if the American imperialists dared to launch a coup d'état, the revolutionary movement would surely gain victory in a great leap. Our analysis was the same. But a coup d'état to topple Sihanouk was inevitable. If it remained, communism would not be smashed quickly. And if they let the revolutionary movement grow, there would be even more troubles. Therefore, we had to gain victory after the Communist Party by long-term infiltration. Only by this way could we achieve our goal.

A number of difficulties raised by our comrades, especially relating to living conditions and security, were not big problems. We could deal with that easily. We had enough money for them. We could contact them. I had already informed His Excellency HANG Thun Hak so that they could facilitate the situation of the comrades in the base, especially the jungle force. Nevertheless, we must not freely conduct our activities during the daytime because the army and police did not understand this issue.

So, we had to know how to escape from that. To sum up, we were neither for Sihanouk's feudalist regime nor for the American imperialists. We were for a new republican regime. Then, Thuch asked me what my opinion would be? How to decide? At that time, I remained silent and tried to continue our activities. But I did not meticulously think about it. After giving me the various above-said instructions, Thuch also raised a number of further measures:

- 1. Comrade Prang (jink) did not return to Sector 41. He [Thuch] accepted responsibility for that Sector. For comrade Prang, he already asked comrade Pok (nn) to keep him in charge of the cores in that place.
- 2. For the revolutionary movement, we had to encourage them to reach as high level as possible.
- 3. The ravaged bases must be strengthened.
- 4. For the bases without unity, we had to educate and induce them to share the same view we had.
- 5. Try to build up core forces to infiltrate as long as possible both within the jungle and the base.
- 6. For our comrades who had been arrested by the enemy and were able to escape from prison, we had to take measures to assemble them. Even though they were true revolutionary forces, if they were with us we had to educate at least some, if not all, of them. But mainly, we had to assemble them for long-term infiltration.

All comrades, if we could build forces, we would greatly benefit because they were already politically influential among the masses. Such infiltration was very good and we also could not easily scattered. Besides imposing measure, I was also asked to get involved with that. I also agreed with the policies. And then, he gave me 5,000 Riels. At 7:00 p.m. comrade Doeun drove me by motorbike back to the base. And then we continued our activities according to those principles. But building traitorous forces was not yet possible. We only could strengthen the ravaged base or the comrades who survived arrest by the enemy. The connection with bases could only be done from the south of Prey Toteung town, while the north could not be contacted because it was severely destroyed.

In 1969, early January 1969, *Angkar* sent 4 more forces: comrades Kēng, Yuth, Poul and Dân, to Phnom Penh. In mid-January 1969, the enemy started their invasion and confronted us. That time, my left hand was broken. The following day, comrade PRÀK Min and comrade KÈ Hau went out to communicate with the base but were arrested and killed by the enemy. In that year, I educated and built the traitorous force; first, *fillegible* comrade Seoun (current deputy secretary of Sector 41), at that time in the village, Chin and Chèm (deceased). In jungle, there were comrade Poul and Yuth.

- Soeun, currently: deputy secretary of Sector 41. In 1969, he was still S.K/K (fis.fi/fi) [incomprehensible]. At that time, he was in charge of food supply.
- Chin died in Chela (1889) II battlefield.
- Chèm was formerly member of Prey Chhor district (shot dead by combatants in late January 1977 in Prey Srâk (វិព្រះត្រវិត), Kampong Siem Khang Leu (កំពង់សៀមហង់ហឺរី) district because Peace alliance was compromised and he fled to jungle in late 1976.
- Poul was current chairman of Zone commerce.
- Yuth, was ranked in a Regiment under comrade Chhin's Division. Currently, there is rumor that he died of illness.

In late April 1969, I had to meet Thuch on a boat floating on the lower Mekong (មេគង្គ) River in Kampong Cham (កំពង់ចាម). On that boat twere: Thuch, Pok (ពក), Doeun, Brother Sat (សាត), Hon (ហុន) and Chhum (ឃុំ).

The meeting at that time was the experience-drawing meeting on fulfilling our duties for the first trimester of 1969. After chatting, we started our work. During the meeting, we were performing the usual Party work. Mainly, it was about the building of support bases in the northern part of the North Zone, which was under the direct command of comrade Pok, then the deputy secretary.

Thuch, the Zone Secretary, had to be in charge of building the base in Kratie ([fife) in order to link with the Party's support base in accordance with the upper echelon.

- Comrade Doeun still remained in charge of Kampong Cham City and a spokesman for the upper echelon to disseminate the news to Zone Committee because the Zone Secretary was too far away to lead as before.
- I (Srēng) was still in charge of Sector 41 and reported to comrade Doeun.

The experience-drawing meeting lasted for 3 days. To sum up, mainly it was about the above-mentioned issues. Then, we separated to our respective bases. Only Thuch, Doeun, me and comrade Khoem (24) (current chairman of Zone Transportation), who was piloting the boat, remained there. On the fourth day, three of us were still working for one morning. This meeting was the discussion of the traitorous activities which would be conducted in 1969 in accordance with the Party's new situation.

Thuch raised the new situation and the Party's preparation in building the support bases of the North Zone in order to link with the Party's above-mentioned support base. He then gave instructions relating to building traitorous forces in lowland areas, cities and upper-land remote bases by saying that:

- We did not need to actively encourage the revolutionary movement in lowland areas.

Mainly, try to build up forces for the long term in a sense to maintain the existing revolutionary force so that it could serve our movement in the future and for a long term – it was the same in city.

- 2. The Zone support bases were also slowed down so that building of their support bases should not be too fast. We had to lead the building in moderate way. Besides, we also had to pay attention to the core forces among the combatants who would be involved in above-mentioned activities.
- 3. In particular, comrade Doeun, who would receive new duties from the Party, had to perform them very well by conducting destructive activities. The destruction would not allow us to stay a long time. The destruction must be in legal way, for instance, by reporting to the enemy on the building of support bases by the Communist Party of Kampuchea, the North Zone, etc. Comrade Kèm had a good way to legally contact the enemy because he was still a public servant.

4. Besides, comrade Srēng's connection must follow comrade Doeun's every activity. And comrade Doeun should continue his work. Relating to any resolvable issue, you should deal with comrade Doeun. "For me (Thuch), I have to go far away and cannot easily to come down here at once." Finally, meticulously keep our individual secrecy and try your best not to let the masses and *Angkar* know that we are conducting traitorous activities against the Party.

5. Relating to some forces arrested and currently detained in prison by the enemy, if they could escape, there must be a policy to assemble them in a sense of continuing our resistance. Gradually, we have to educate and induce them. This force is very important to us, but we have to be cautious of our activities. We should not want to get it immediately. It also should be done the same way in Sector 41 and cities. At this point Thuch stopped giving instructions and started asking for suggestions. Everyone agreed on this policy. Then, the evening came and we said goodbye and went back to our respective bases.

When arriving at the base, I started arranging the activities to contact with former base people. But we did not use armed force as a means to induce and force for the revolution. At that time, the base was located at the south of Prey Toteung. That base was use for re-connecting the forces but we did not improve anything important. We just used it for finding food supply because there only the wives of our comrades who had been arrested by the enemy were living there.

In October 1969, I met comrades Pork and Doeun again in Kampong Cham city. During this meeting, comrade Doeun brought about the Angkar's guidelines relating to the Party's views on new situations and measures.

Everyone also agreed on the Party's view on the situations and discussed new directions that we had to assemble forces for building the abovementioned bases. At that time, three of us agreed that the forces should be assembled from Sector 41 up to the top.

We waited to assemble the forces from prison. If they were willing to sacrifice, we would take them all.

Since late 1969, the enemy had released our comrades one by one, especially in Sector 41 including Trapeang Bei base as well as the base south of Prev Toteung. I also arranged connecting forces by dividing into two parts:

- I went to stay in Kampong Cham City in order to communicate with our comrades using legal ways to enter and leave the city.
- In the jungle, I left comrade Srun (ស្រ៊ុន) (currently: secretary of Stoung district) in charge while comrade Poul and comrade Keng were also partly involved in connecting, especially the bases near Prey Boeng (เก็ตน์น). The induction of the forces from prison was finished in January 1970; but we could not assemble all of them.

In Sector 41, we assembled:

- 1. Comrade Sây (currently: in comrade Chhin's Division)
- 2. Comrade Yan (ting) (id)

- 3. Comrade Yoeung (comrade Sây's younger brother/sister-in-law). I heard he was in Office 870 but unknown section.
- 4. Neary (5) (comrade Sây's wife)
- 5. ... Neary (comrade Sây's elder sister-in-law)

At Trapeang Bei base:

- 6. Comrade Khăn (1918), currently: deputy chairman of rubber plantation.
- 7. Comrade Yun (tigs), comrade Khăn's younger sibling (deceased).
- 8. Comrade Vocung (អ៊ី]ង), currently: deputy chairman of Division 310.
- 9. Comrade Kim (គីម), formerly: deputy chairman of Division 310.
- 10. Comrade Vēng (អ៊ីង), currently: deputy chairman of a Division in the North Zone.
- 11. Comrade Sun, currently: secretary of Chi Kraeng (ជីវ័រុក្រង់) district (Sector 41).
- 12. Comrade Neary, Brother Sun's wife.
- 13. Comrade Mão (١٤٦) was current a member of Sector 41 commerce.
- 14. Comrade Dân (ህይ), comrade Beng's (ነነነቱ) younger sibling, current secretary of Puok (អ្នក) district, was deceased.
- 15. Comrade Neary Chou (ម្ចាំ) was comrade Kim's younger sibling.
- 16. Comrade Keat (កាត) was current secretary of Cheung Prey (ហើង भैंभि) district (Sector 41).
- 17. Comrade Kăn (mis) was current deputy secretary of Cheung Prey district.
- 18. Comrade Chhun (ASS) (female) was current member of Sector 43.

All of them were arranged for building the above-mentioned bases. In early February 1970, there were also forces sent to the above-mentioned bases. Sector 41 was left free for a while and let comrade Doeun to keep in contact based on the realities. But at that time, comrade Doeun was organized (current deputy secretary of Sector 41) to lead the movement. Basically, at least we maintained both traitorous and revolutionary forces for the existing movement. We also continued building the traitorous core force. In late 1969, I did not build any traitorous forces.

From cities, we saw that comrade Mân ("B") (currently: in charge of the State Communication), comrade Chuon (ជំនិ) (died of illness in 1974), comrade Suon (ស៊ុន) or Pon (ប៉ុន) (died in 1973) as well as former force were sent to highland jungle.

When arriving in Prey Tuol Sambuor (ព្រៃទួលសំបូរ) (upper part of Stueng Trang (ស្ទីងត្រង់)), the news of coup d'état was disseminated. At that time, comrade Pok, Doeun and I held a meeting to arrange our following duties for building the referral base:

- 1. Comrade Pok was in charge of overall work and, in particular, building base in upper part of Praeak Prasab (ព្រែកប្រសប់).
- 2. Comrade Doeun was still in charge of cities and low-land areas.
- 3. I (Srēng), in charge of upper part of Santuk (សន្នក) district.
- Brother Sath (ជាធ) was in charge of upper part of Stueng Trang.
- 5. Comrade Soth was also in charge of upper part of Stueng Trang.
- 6. Comrade Sei (សី), current in charge of a Division in the North Zone), was also in charge of transportation.
- 7. Comrade Chhum (fled to Vietnam in 1974) was also in charge of upper part of Praeak Prasab.
- 8. Comrade Hon was in charge of the central office.

After this arrangement, I followed the direction and traveled to Boeng Lvea (ប៊ីងណុ) base, the upper part of Santuk district, which had been liberated. Then, I stayed there and established the authority for that base for a month before going back to meet comrade Pok at the office.

... and following the imperialist way was also fast because it was built with money. I also further instructed that we had to provide those opportunities by letting them to learn at the intelligence school in Kampong Cham or any other places where they could afford. Through that, we educated them to understand more about our issues. We should not let them only think about pleasure, money and women which were poisoned by the enemy.

The former force and the force from the imperialist intelligence helped to build continuously at Prey Chhor district base. Mainly, the revolutionary authority at that time belonged to the Peace alliance. And the force built in 1971 for a long run was as follows:

... while the geography was also quite large spreading until reaching Vietnam along the Bassac (ຖືກກໍ່ກໍ່) River. So, it was not easy to grab it with one attack. It would be more secure if people outside, like you, conducted further activities.

For the intelligence network which was in danger, he requested protection. If they could not be protected, they were suggested to get back inside.   - But [I] would like to suggest following measures:

#### 1) About the situation of high-ranking military officers

After the whole country was liberated, *Angkar* has continuously imposed the policy to smash high-ranking military officers from generals down to lieutenants as well as spies, police officers, gendarmerie officers and reactionary public servants.

So far, at the various bases, the Party's guidelines have been continuously implemented. In every Sector, those guidelines were also applied. The Zone imposed this policy of sweeping clean from generals, colonels, lieutenants and even down to (active) rank-and-file soldiers. This activity was actively conducted. Each Sector constantly made and proposed them to the Zone, which also dealt with them one after another. Activities to research and find the high-ranking military officers have been conducted until now. Hundreds of the high-ranking military officers and thousands of rank-and-file soldiers have been swept clean. That is what was implemented.

- The measures related to high-ranking military officers have been applied since liberation day until now. But in 1975 and mid-1976, the many were swept clean. As for finding them, it was not the Zone Committee that knew them: the bases that had investigated and checked and found them among the masses.

As for traitorous plans, there was not any policy to hide them, but there was an activity line not to break secrecy; otherwise the hiding of high-ranking military officers would jeopardize our movement because those officers could be hidden among the masses. In conclusion, there was no any policy to spare high-ranking officers, either those who had scattered and ran or those who had not. So far, in every base, many of these high-ranking officers were arrested one after another, and the Zone decided all along to sweep them clean.

I would like to seek mercy from *Angkar* for my response regarding the issue of hiding high-ranking officers. Moreover, hiding them would not bring me any benefit.

#### Additional clarification:

So far, there have been some indecisive views regarding to purging these high-ranking officers, for instance:

- Comrade Chiv (ជីវ) (formerly secretary of Tang Kouk district), already detained, had intended to hide them on the pretext that he was not sure perhaps due hatred they had been falsely reported. He kept saying that he was not sure until those high-ranking officers assembled their soldiers and came to fight and got 6 guns from the district army (in May 1976). But the Zone assigned me to smash them. Finally, they were all smashed successfully and we got 5 guns back, losing only one that fell into a lake and could not be found.

Comrade Krauch (ក្រុច) (chairman of Sangkat Krala Leu (សង្កាត់ ິງກິຊິກິກົນ), Kampong Siem district) also hid them. But the Zone learned about that and imposed some measures (in Prey Chakrey (ព្រៃចក្រែ) and Anlung Snauk (អន្តុងស្នុក) villages, Sangkat Krala Leu).

Aside from this, are there any others left? I would like to inform Angkar that regardless, those high-ranking officers have not been 100% purged from bases in the Zone. For this point, I would like to suggest Angkar to ask other comrades here for details on which I have no grasp.

I have reported honestly, without concealing anything, and would not dare [fear] to reveal this group to Angkar any more than the comrades in the internal ranks of the Party.

His activities were to destroy good cadre, for instance, Tēng (secretary of Tong Rong sub-district) and Mân (secretary of Samroang sub-district) get severely wounded. At that time, it was Kăn who was shooting them, but Kăn has already been smashed.
- 2. Oeun, Company rank, was Keo's network. This person started to betray in 1973. He was captured by the enemy during the battle in Kampong Cham city and was only freed after 17.4.75.

# Traitorous network within Division 117, Zone 303

- 1. Hâm, regimental rank, Hoh's network, was inactive in 1968. Hoh contacted him in 1976.
- 2. Kuch (his rank: member of Logistics, Division 117) is currently in charge of warehouse in Kampong Thom. His duties were to maintain weapons in a legal way. He was Hoh's network. He was built during the war in 1974 in Siem Reap.

- 3. Comrade Sean (ជាន), Sector 106 commerce, was organized by Thuch and transferred to Soth. Sean used to contact in and out of Siem Reap city and contact RUT San (វត់ ជាន) on Thuch's behalf.
- 4. Da (ង1), former force through Pech, was member of Chamkar Andoung rubber plantation.
- 5. Suon, was former secretary of Varin (his) district. He was removed from his position because he had committed moral offence for 6<sup>th</sup> time and then was married to Neary Preab (shiffing), a former artist of 304. Currently, not sure but probably he was living in Preaek Prasab.
- 6. Nau (M) was secretary of Anlong Veaeng district in Sector 106. I was told that he had committed moral offence many times; but I did not know about his situation currently. He was Soth's organized force.
- 7. Cheam (ជាម), a district secretary of Sector 106, was Soth's organized force.
- 8. Chea (氧) was former chairman of Sector 106 commerce. He fled to join the enemy in 1973 because he had been compromised about his contact with the enemy. Comrade Soth had instructed him to flee.

9. Chăn (🏟), was former deputy secretary of Puok district. During 5-year war, he was a teacher and the enemy's Peace alliance infiltrating agent and was friendly to comrade Soth.

About the current traitorous activities in the North Zone (at the bases, ministries, military offices, where I can grasp their names)

#### Sector 41:

- 1. Tăng (current position: secretary of Sector 41), joined the revolutionary movement in Prey Chhor district during the political resistance. In 1968, he was inactive until the coup d'état. After the coup d'état, he went back into jungle. I just refashioned him in 1971 because before that he had been in this base under comrade Peou's (m) command (Peou died in 1968).
  - Conducted traitorous activities and received the leading role in the traitorous network in Sector 41 from me.
  - Stirred up confusions everywhere.
  - Destroyed the plan to grow rainy-season rice with the excuse of rain shortage. But he did not do it at the places where there was enough water. As a result, people were starving in 1977 up to the amount of thousands of tons of rice.
  - Caused hundreds of people in Batheay district to die of starvation while Prey Chhor district had rice.
- 2. Chhean (currently: secretary of Batheay district), was Doeun's organized network and transferred to me in 1965. But in 1968 Doeun asked to get him back and transferred to Suong (NI) (rubber plantation).
  - Activities from 1971 to 1973: He was working in Kampong Siem district. He was contacting the enemy and sold them rice and pigs.
  - Activities after the liberation: He hid high-ranking officers in Batheay district. So far, some were solved but in split situation when he was the deputy secretary of Prey Chhor district. In 1973, he was organized to command traitorous network with Sèn and Chèm.

He was only in charge of food supply and educating some forces in Kampong Siem district such as: Chin (ជំន) (currently: chairman of commerce in Kampong Siem district) & Krauch (ក្រិម), secretary of Sangkat Krala Leu, Kampong Siem district.
- 6. Saor, currently: secretary of Batheay district was in charge of food supply like comrade Chhean, the district deputy secretary.
- 7. Chin, currently: chairman of Prey Chhor district hospital, was my network since the political resistance. In 1968, we separated because he went away to run his business. We met again in 1971. Chin was active in activities infiltrating female spies within the hospital and contacting with military hospital 310.

He was educated by comrade Sèn in 1971.

- 22. Kai (កែ) was secretary of Sangkat Vihear Thum (សង្កាត់វិហារធំ),

Kampong Siem district. He also used to join the movement during the political resistance. In 1968, he ran away from the revolution and paid bribe to the enemy so that he could stay and home safe and sound. After the coup d'état, he still did not join it. After the liberation, comrade Soeun called and promoted him to Sangkat chairman. He was just educated by Soeun. His previous activities: he did not lead people to grow crop. He was also the Zone's core traitorous network during the war.
- 2. Suor (currently: secretary of Praeak Prasab district) was my network since 1967. In 1968, he ran away from the revolution to live in Phnom Penh. After the coup d'état, he came to the line. I also took him back. He was secretly supplying food for enemy during the war (when he was secretary of Kampong Siem district). In the current traitorous activities, he was comrade Tol's member. His previous activities were to obstacle the storm attack in doing agriculture production in Baray district, Sector 42. He also liked to spread a rumour that the enemy was conducting activities like this or like that etc.

When he was arrested by the enemy, he confessed to enemy. He used to conducted activities with comrade Doeun during the incident in Kampong Thom in 1974.
- 2. Pan: secretary of Sandan district (already arrested), also Doeun's network, refashioned during the war. This person was only after the coup d'état. His activities toward people were so hideous. For instance, when people made a mistake, for example buffaloes ate crop, he arrested and tortured them. He also let people to run away to Thailand freely.

3. Khēng (secretary of Kampong Svay district): already arrested. Previously, this person was France's spy in Boeng Pê (ប៊ីងពី) rubber plantation. During the 5-year war, Khēng was constantly contacting the enemy. In 1973, he was educated by comrade Doeun and under his command since then. He was detained because of his connection with bandits. Currently, he is detained at the North Zone Special Branch Office.

#### Zone Rubber Plantations:

- 12. Pech, member of the Rubber Plantation Committee, was my network since 1966 and then transferred to Mitt (មិត្ត) in 1967. In 1969, he passed exam to be a teacher. In 1966-67, when Pech was still studying at Prey Toteung Junior High School, he conducted activities to destroy the revolutionary movement in the school by intimidating and stopping the contact and education. In 1967, the movement at the school was completely inactive. His activities at the rubber plantation: stirring up quarrel and partisan, disrespecting for common interest, creating hooligan situation among the workers as well as keeping calm in order to assemble force within the workers syndicate.
- 13. Khèm, member of rubber plantation committee, was comrade Doeun's network. In 1974, he moved to Kampong Thom battlefield. At that time Khèm contacted the enemy from Kampong Thom and brought them to stay in rubber plantation, while Pech was the person who [illegible].

# The Zone Military (Division):

- 1. Hoh, member of the North Zone Division (117), was particularly in charge of a Regiment. In 1971, this person used to contact enemies named MĂNG Marunèl and monk PANG Khặt in Cheung Chhnok (ਪਿੰਸ਼੍ਰੇਸ਼). In 1964, he had originally joined the revolutionary movement as a progressive. But when the situation became very intense, he ran away from the revolution, became a musician, travelled a lot, and did not stay in one place. After the coup d'état, he came back to the revolution in Kang Meas district. When he went to Siem Reap, he was refashioned by Thuch (1974). His traitorous activities were that he in charge of the traitorous force within the Division of the North Zone.
- 2. Hâm was member of the North [Zone] Division. He had previously joined the revolutionary movement (1966, 1967). In 1969, he was in Agriculture. He was built by Hoh in 1976 because they were long-time, close friends. His activities were not significant, just simply in charge of the traitorous duties as deputy chairman of the Division.
- 3. Duong, regimental level, detained at the Zone Special Branch Office. He was built by Hoh in 1976. He did not conduct any activity openly. His traitorous duties were that he was member of the Division.
- 4. Kuch was current member of Division Logistics in Kampong Thom. His traitorous duties were that he was chairman of the Division Logistics. His current activities are: storing and maintaining weapons and ammunition in the warehouse in Kampong Thom.
- 5. Snao, battalion level, Zone Division (117), was Hoh's network (already detained).
- 6. Rĭn, battalion level, was Hoh's network in 1976 (already arrested).

I would like to add that there were some more people in the lower levels, but I cannot recall their names.

#### The Division of the old North Zone transferred to *Angkar*:

- 1. Oeun, current chairman of Division 310, was refashioned by Thuch after the coup d'état. After Oeun returned from the Southwest Zone, following Thuch's instruction, he joined in the activities of preventing the Party's storm attack. His activities (1977): his duties were to cheat in Phnom Penh following Doeun's instruction.
- 2. Suong, chairman of Division 450, was also refashioned by Thuch during the war. His activities were the same as Oeun's.
- 3. Voeung was deputy chairman of Division 310. This person helped to progress the revolution in 1964 at the base in Prey Chhor district. In 1968, he conducted a riot to fight and get the weapons. Then, he was arrested by the enemy. He was refashioned by comrade Oeun but I am not sure. Comrade Oeun told me about that.
- 4. Phèn, ranked in Regiment of Division 450, was comrade Suong's network. He was Suong's network during the war.

6. Yoeun (in logistics, Division 310) currently standing by at

Praeak Kdam (រីព្រឹក្សាម), was Oeun's network. In 1976, this Yoeun contacted Loeun (ហើន), a bandit who disguised himself to live along the West-North Zones border. Yoeun often stationed at various places to raises his cows without contacting the local authority. So far, there had been clashes

between Batheay district and Sector 15 about the case that the cows eating rice plant. Batheay and Sector accused each other

about that but in fact it was Division 310's cows.

- 7. Han (MS), was chairman of a Battalion of comrade Suong's Division 450. Previously, this person was refashioned by comrade Nân (MS) in 1972. When comrade Nân deceased, I tried to assemble him to be under my command. Currently, he was under comrade Suong's command. He used to join the traitorous activities when he was in Kampong Cham in 1973.
- 8. Lum (心) or Dēt (铅筒): after liberation, this person was used by comrade Chhoeun in the ministry of commerce and then transferred to comrade Suong in 1976. This person was refashioned by Chhoeun in 1968. During the war, Lum was staying in Kampong Cham until 1973. Then, he went out of the city to contact the enemy as usual. This person was very selfish. He often brought quarrel to any place he went to.
- 9. Chum (ង្) was ranked in a Regiment of Division 310. Chum used to live in jungle with comrade Suong during the internal war. In 1973, Chum was in charge of Sector 42 military. When the Party planned to attack Phnom Penh in 1975, Sector 42 transferred a Battalion to Chum. In 1973, during the battle in Kampong Cham, Chum conspired a traitorous movement with Hoeung by killing many good combatants because they did not agree to stay behind. When in Division 310, he was under comrade Oeun's command. Now, I have no idea about his whereabouts.

Related to the Division of the old North Zone, I would like to finish my reporting here. I could only recall the above names because these Divisions were not under my regular command.

### Other ministries on the *Angkar*:

- 1. Chhoeun: member of State Commerce, Thuch's and Doeun's network since the political resistance. I could not grab his activities. But in 1968, Chhoeun destroyed the movement at one place, when he was just a teacher at Stoung Junior High School (Kampong Thom), according what I was told by Thuch. After he lost contact with Thuch, his other activities could not be grabbed. Then, comrade Doeun took him to be under his command.
- 2. Mâm, chairman of State Water-Way Transportation, was Doeun's long-time network since he was at the textile factory in Kampong Cham.
- 3. Yân, current cadre of the commerce in charge of raising pigs for the state, Thuch's network, was refashioned during the war with comrade Tol, current secretary of Sector 42.
- 4. Kèm, current diplomat to Laos, was Thuch long-time network since the political resistance. Previously, Kèm also regularly contacted the enemy by using legal means because at that time, he was a public servant.
- 5. Kēng was former secretary of Kampong Svay district, Sector 43. In late 1976, he was transferred by the Zone to *Angkar*. He was educated by me in 1969 when we went in jungle but at that time he was not profound. Then, during the war, he was also refashioned by Thuch in Siem Reap. His activities were preventing the Party's movement by doing anything without listening to others. For example, in Sector 43 (1976), when he thought of digging water canal and building dam, he just did it without asking for the advice from upper-echelon, etc.

- 6. Chhăm (xi), currently standing by at the National Assembly, was refashioned by Thuch for a long time, since Uncle Preab's time. Previously, he had been a messenger in contacting the enemy with Preab whenever Thuch needed it.
- 7. Sǎo (६६६), current cadre in the Ministry of Foreign Affairs, was Thuch's network since the political resistance. But, he was outside the city.
- 8. Chhean (currently: diplomat to Vietnam). Previously, I had no idea from which base he had joined the revolution. But in late 1968, I met him at Kèm's house with Thuch and Doeun. In 1969, he was inactive until after the coup d'état when he came back to the line in Kaoh Soutin (កោះស្គីទីន) (the East Zone). At that time, there was a letter to Thuch requesting to transfer him to the North Zone. But Thuch instructed him to the East Zone instead. I did not grasp his activities against the revolution (comrade Doeun knew about that clearly because he was the inside network).

#### Kratie, Sector 505:

- Comrade Kâng (គង), current deputy secretary of Sector 505, was comrade La's (ឡា) network. In 1966, he was transferred to Thuch who assigned him to the above place. In Sector 505 but I did not know the exact place. Also, this base was arranged by Thuch and Doeun during the internal war. I only knew in general that it was the base built by Thuch.

... after liberation. Even though Thuch said that this movement was around the country, he did not mention the names

But after the whole country was liberated, Thuch said that:

- In the Northwest Zone: comrade Vanh (ก็ก), currently member of the Northwest Zone, was in charge of the movement in the Northwest Zone. I asked when it had been built. Thuch responded that it had been built for a long time. However, I did not grasp the real situation. And when I contacted Vanh occasionally, I never asked him about the traitorous activities. We were just friendly.
- In the West Zone: Comrade Hâm (formerly: secretary of Sector 15). But Thuch did not mention Brother Keo. But Keo used to contact me for rice, corn supply and materials for rice paddy fields (1974-1975). And the way he talked about Angkar was offensive.

For example, he told me that previously he had attended the Independence anniversary celebration (1976). And said there were a number of leaders presiding over the ceremony. Constantly, he used "them" ("sp") [Translator note: Ke is refers to third person(s) of equal or even lower levels] when he referred to the upper echelon.

#### Sector 106:

- 1. Soth, current secretary of Sector 106, was Thuch's network. His current traitorous duties were that he was in charge of Sector 106 and especially contacting people from the West Zone.
- 2. Khoeun was a district secretary in Sector 106. In 1966, he was transferred by comrade Doeun to me so that I infiltrated him within the base. But in late of that year, I transferred him to Kampong Saom (กักินันาย) in order to infiltrate within the revolutionary movement there, if any. But Khoeun stayed there for a while and then found a way to pass the exam to be teacher. In 1970, he taught in upper part of Stueng Trang and then met comrade Doeun again after the coup d'état. Then, he was instructed by Thuch to go to Siem Reap with comrade Soth in late 1970. His current activities: an agent to contact people from the West Zone on comrade Soth's behalf.
- 3. Sean (FIS) was chairman of Sector 106 commerce. In 1973, he contacted the enemy in Siem Reap city. His father was a long-time soldier. When Hoh moved to Siem Reap battlefield, both of them started their connection since then.
- 4. Chea, was former chairman of Sector 106 commerce. In late 1973, he ran to join with the enemy because of his contacts with the enemy were compromised: for example, he secretly allowed the capitalists in Chi Kraeng to run to the enemy. Comrade Soth instructed him to withdraw himself; otherwise this would be compromised to upper echelon.

- 11. Comrade Bēng (ជាង) is current secretary of Puok district. I could not grab him. But since comrade Bēng left the enemy's prison in 1970, he stayed with comrade Doeun closely until he was with Thuch from late 1971. In 1974, Thuch was very close with Bēng.
- 12. Brother Sun, current secretary of Chi Kraeng district, was a person from Prey Chhor district. In 1973, he was transferred to Sector 106. I did not refashion Sun because while in the base he was comrade Peou's network. During the riot in 1968, he was arrested by the enemy. But these two comrades were in the same planned refashion by comrade Soth.

#### About the Sector 106 military:

- 1. Hean was chairman of Sector 106 Division. His previous biography: in Kampong Siem district, Kampong Province. His father Ung (भूष) was a revolutionary (deceased). After the coup d'état, comrade Hean became a soldier for 2 months and returned to his line. He was refashioned by Thuch during the war. His current activities were not grabbed.
- 2. Pēng (ហ៊ង) was regimental level in the Sector 106 Division. His previous biography: a spy in Kratie. After the coup d'état, Kratie was liberated, Pēng ran to Siem Reap to join the revolution there. In 1972, Pēng and Hoh got to know each other and conducted activities together at Angkor (អង្គរ) battlefield. Currently, he was under Soth's command. He was a cruel person ...
