Arrest Warrant Mandat d'Amener

I, Mark B. Harmon, International Co-Investigating Judge of the Extraordinary Chambers in the Courts of Cambodia ("ECCC");

**Noting** the Law on the Establishment of the Extraordinary Chambers in the Courts of Cambodia, dated 27 October 2004 ("ECCC Law");

**Noting** Rules 11, 15, 21, 22, 41, 42, 45, 51, 55, 57 and 72 of the ECCC Internal Rules ("Internal Rules");

**Noting** the Co-Prosecutors' Second Introductory Submission Regarding the Revolutionary Army of Kampuchea filed on 7 September 2009;<sup>1</sup>

**Noting** the Co-Prosecutors' Supplementary Submission Regarding Crime Sites Related to Case 003 filed on 31 October 2014 ("Supplementary Submission");<sup>2</sup>

Noting the judicial investigation relating to alleged violations of the 1956 Penal Code, Crimes against Humanity and Grave Breaches of the Geneva Conventions of 12 August 1949, offences defined and punishable under Articles 3(new), 5, 6, 29 and 39 of the ECCC Law and Articles 500, 501, 503, 505, 506, 507 and 508 of the 1956 Penal Code;

**Noting** that Meas Mut is a named Suspect in the Introductory Submission and the Supplementary Submission;

**Noting** the Disagreement registered on 17 July 2014;

Noting the following regarding Meas Mut's identity:

**Noting** that, on 26 November 2014, the International Co-Investigating Judge issued a summons for Meas Mut to appear at the ECCC for an Initial Appearance on 8 December 2014;<sup>3</sup>

**Noting** that Thomas Kuehnel, Investigator at the ECCC, served this Summons on Meas Mut on 28 November 2014;<sup>4</sup>

**Noting** that in a letter dated 2 December 2014, Meas Mut informed the International Co-Investigating Judge that he did not recognize the validity of a summons to Initial Appearance issued by a single Co-Investigating Judge;<sup>5</sup>

**Noting** that on 3 December 2014, the Co-Lawyers for Meas Mut informed the Co-Investigating Judges that their client did not intend to comply with the summons and will not be present at his Initial Appearance scheduled on 8 December 2014;<sup>6</sup>

**Noting** that in the Response to the Notice concerning Mr Meas Muth's decision not to recognized summons Dated 3 December 2014, the International Co-Investigating Judge recalled that the Pre-Trial Chamber had already affirmed the validity of a summons for Initial Appearance issued by one Co-Investigating Judge, provided that the disagreement procedure set forth in Internal Rule 72 has been complied with and that the 30 day time period to bring it before the Pre-Trial Chamber has elapsed.<sup>7</sup>

Noting that Meas Mut failed to appear for this Initial Appearance;

**Noting** that Meas Mut's National Co-Lawyer, Ang Udom, appeared at scheduled Initial Appearance and declared that Meas Mut refused to appear on the ground that that he did not recognize the validity of a summons to Initial Appearance issued by a single Co-Investigating Judge;<sup>8</sup>

Hereby **order** the Judicial Police to execute this arrest warrant (*mandat d'amener*) forthwith;

The Judicial Police shall not enter the residence of Meas Mut prior to 6:00 a.m. or after 6:00 p.m., and the Judicial Police shall notify the International Co-Investigating Judge of any difficulty in performing their mission;

The Judicial Police shall bring Meas Mut before the International Co-Investigating Judge for an Initial Appearance. If Meas Mut, due to the circumstances, cannot be brought before the International Co-Investigating Judge immediately, he shall be placed in temporary detention, wherever possible in the detention facility of the ECCC, and presented to the International Co-Investigating Judge as soon as possible.

Meas Mut has the following rights under the Internal Rules:

- The right to lawyers of his own choosing as provided in Internal Rules 11,
  21, and 22 and the applicable administrative regulations,
- The right to have a lawyer present during his Initial Appearance pursuant to Internal Rule 57,
- The right to remain silent pursuant to Internal Rule 57,
- The right to make a recorded statement with a lawyer present during his Initial Appearance pursuant to Internal Rule 57, and
- The right to consult with a lawyer prior to being interviewed at any stage of the judicial investigation;

Should he be placed in temporary detention because he cannot be brought before the International Co-Investigating Judge immediately, Meas Mut has the following rights under Internal Rule 51:

- The right to request to see his lawyer, who shall be informed of the request immediately, by all means available, and
- The right to meet with such lawyer or, if this is not possible, a lawyer provided by the Defence Support Section, for a maximum of 30 (thirty) minutes before he is presented to the International Co-Investigating Judge. Such lawyer shall have the right to be present during the period of police custody, subject to the administrative requirements of the detention facility;

The International Co-Investigating Judge requests that all competent authorities provide any assistance that may be requested by the Judicial Police in their execution of this arrest warrant (mandat d'amener).
