Mr. MEAS Muth, through his Co-Lawyers ("the Defence"), hereby requests the Pre-Trial Chamber to order the OCIJ to provide the Defence with the following Case 004 material: a. the International Co-Prosecutor's Request for a Reclassification of Documents for Disclosure to the Pre-Trial Chamber and Parties in Case File 003, 6 March 2014, D184; b. all material related to the assignment of Mr. Bit Seanglim; c. all material related to the assignment of Mr. So Mosseny; and d. all material related to the assignment of Mr. Richard Rogers, including all submissions and decisions related to the litigation concerning Mr. Rogers' assignment. This Request is made necessary because Co-Investigating Judge Harmon has ordered four Case 004 documents to be placed on the Case 003 Case File in redacted form. These four documents relate to the assignment of Mr. Bit Seanglim, Mr. So Mosseny, and Mr. Richard Rogers. Without the requested material, the four documents are without context. This Request is made to the Pre-Trial Chamber because the requested material relates to the conflict of interest appeal currently pending before the Pre-Trial Chamber² and because the Co-Investigating Judges have ignored every recent Defence submission,³ even refusing to place the submissions on the Case File, in violation of the Internal Rules.⁴

I. RELIEF REQUESTED

WHEREFORE, for all the reasons stated herein, the Defence respectfully requests the Pre-Trial Chamber to ORDER the OCIJ to place the requested material on the Case 003 Case File and make it available to the Defence.
