#### **SUBMISSION**

- On 17 June 2015, the Supreme Court Chamber ("SCC) issued its directions on the conduct of the upcoming appeal hearings in which Witnesses SCW-3, SCW-4 and SCW-5 are scheduled to provide testimony.<sup>1</sup> The SCC ordered each party to submit, no later than Wednesday 24 June 2014 and via email addressed to its Greffiers as well as to the other parties in Case 002/01, a list of the materials the party intends to use during the witnesses' questioning.<sup>2</sup>
- 2. In accordance with the SCC's order, the Co-Prosecutors hereby submit the list of materials they may use during the questioning of Witnesses SCW-3, SCW-4 and SCW-5, which is attached as Annex A. The annex includes the number and title of each document as required by the SCC. For documents exceeding 30 pages, the ERNs of the portions that may be used are included, with the exception of prisoner lists. Presently the Co-Prosecutors are unable to identify the specific parts of the prisoner lists that may be used as the relevant portions (specific prisoner data) of these lists will be dependent on the specific nature of the witness testimony.
