Summary of Proceedings

Opening of hearing and report on attendance of the Parties

NUON Chea Defence request for clarification with regard to the recent disclosure of sixty-six DC-Cam statements concerning Trapeang Thma Dam Worksite

The Trial Chamber questioned the Co-Prosecutors on the issue of the translation of the sixty-six DC-Cam documents from Khmer into the Court's other working languages. The Co-Prosecutors stated that the documents had all been available to the Trial Chamber and the other Parties since June 2014 and that a summary of the content had been provided. Furthermore, the Co-Prosecutors explained that twenty-five documents had been translated into English and the other translations were ongoing. The KHIEU Samphan Defence observed that the documents concerned have already been assigned an E3 number by the Chamber and thus have been put before it, without the majority of the Defence team members being able to read their content and submit observations thereon. After the recess, the Co-Prosecutors informed the Trial Chamber and the Parties that the request for further translation had not yet been made. The Trial Chamber stated it would provide its decision in due course.
