# PRAKAS/EDICT

ON

THE ACCREDITATION OF NEW INVESTIGATION OFFICER OF THE OFFICE OF INTERNATIONAL CO-INVESTIGATING JUDGE OF THE EXTRAORDINARY CHAMBERS IN THE COURTS OF CAMBODIA

#### THE MINISTER OF JUSTICE

- NOTING the Constitution of the Kingdom of Cambodia;
- NOTING Royal Decree No. NS-RKT/0913/903 dated 24 September 2013 on the Appointment of the Royal Government of Cambodia;
- NOTING Royal Kram No. 02 NS/94 dated 20 July 1994 promulgating the Law on Organization and Functioning of the Council of Ministers;
- NOTING Royal Kram No. NS-RKM/0196/04 dated 24 January 1996 promulgating the Law on the Establishment of the Ministry of Justice;
- NOTING Royal Kram No. NS-RKM/0801/12 dated 10 August 2001 promulgating the Law on Establishment of the Extraordinary Chambers in the Courts of Cambodia;
- NOTING the Internal Rules of the Extraordinary Chambers in the Courts of Cambodia dated 12 June 2007;
- NOTING the revised Internal Rules of the Extraordinary Chambers in the Courts of Cambodia dated 1 February 2008;
- REFERRING TO Letter No 10462 ECCC/OA dated 13 July 2015 from the Extraordinary Chambers in the Courts of Cambodia;

## **DECIDES**

Article 1: One new investigation officer of the Office of International Co-Investigating Judge of the Extraordinary Chambers in the Courts of Cambodia has been accredited. His identity is as follows:
