Summary of Proceedings

Opening of hearing and report on attendance of the Parties

The President opened the proceedings and the Greffier informed the Trial Chamber that all Parties were present. The Accused NUON Chea was present in the holding cell.

NUON Chea Defence request to follow the proceedings from the holding cell

The Trial Chamber granted the request of the NUON Chea Defence for NUON Chea to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

NUON Chea Defence request for clarification with regard to a number of DC Cam statements not available in English and/or French

The NUON Chea Defence raised a question pertaining to the use sixty-six DC-Cam statements, the summary of which was recently disclosed by the OCP in the present hearings (E353). The NUON Chea Defence noted that of the sixty-six original DC-Cam Statements, only thirteen, including the one it intended to use (E3/8991), had been translated into English and none into French. The Trial Chamber requested the NUON Chea Defence to provide the full list of sisty-six documents to the Chamber so that it could consider the matter.

Hearing of Civil Party SEN Sophon (2-TCCP-220)

The NUON Chea Defence and the KHIEU Samphan Defence questioned Civil Party SEN Sophon (2-TCCP-220). The Civil Party made a victim impact statement.

Hearing of Witness MAM Soeurm (2-TCW-858)

The Trial Chamber, the Co-Prosecutors and the Civil Party lead Co-Lawyers questioned Witness MAM Soeurm (2-TCW-858).

NUON Chea objection to the Co-Prosecutors' questioning in light of Supreme Court Chamber Decision F26

The NUON Chea Defence objected to the Co-Prosecutors' manner of questioning Witnesses by putting to them excerpts of prior statements and asking for confirmation. The other Parties also presented their views. The Trial Chamber instructed the Parties to ask open questions, and clarified that in the case of an inconsistency, the relevant passage in the statement can be cited in order to clarify the matter and ask follow up questions.
