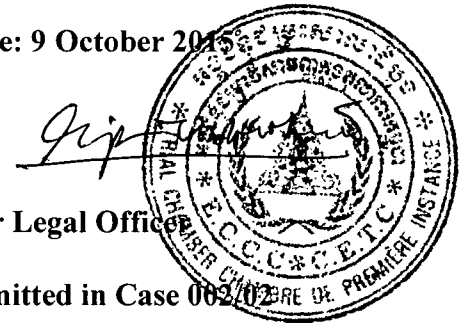

**SUBJECT: Allocation of E3 numbers to New Documents Admitted in Case 002/02**

1. Throughout the trials in Case 002/01 and Case 002/02, documents arising from the investigative phase that are subsequently admitted by the Chamber have been allocated E3 numbers (E185, paras 2, 33; E185/1, para. 18; E185/2, para. 27; E305/17). The E3 number designates admitted documents that may be put before the Chamber and relied upon by the Chamber in making its decisions pursuant to Internal Rule 87(2) (*See also*, Case 002/01 Judgement, para. 23; Case 001 Judgement, para. 38).

2. In Case 002/02, the Trial Chamber has been seised of and ruled upon numerous requests to admit new documents pursuant to Internal Rule 87(4). Upon filing, the proposed new documents are allocated an E number as attachments to the relevant Internal Rule 87(4) requests, prior to their being reviewed pursuant to the requirements of Internal Rule 87. Where such new documents are admitted and put before the Chamber, they may also be relied upon by the Chamber pursuant to Internal Rule 87(2). However, it is more difficult to track which new documents have been admitted and which have been rejected since both categories of new documents retain an E number (*See e.g.*, T. 8 September 2015, p. 18).

3. In order to facilitate tracking of admitted new documents, the Chamber has decided to reinstitute its prior practice of allocating E3 numbers also to new documents that have been admitted pursuant to Internal Rule 87(4) (E190, para. 18). The Chamber therefore attaches a list of E3 numbers for all new documents admitted by the Chamber in Case 002/02. While the full list is always available to the parties in the Zylab inventory of E3 documents, the Chamber will also update the attached list periodically.
