#### Summary of Proceedings

#### Opening of hearing and report on attendance of Parties

The President opened the proceedings and the Greffier informed the Trial Chamber that all Parties were present. The Accused NUON Chea was present in the holding cell.

#### Order under Internal Rule 79(4) for the continuation of the proceedings

The Trial Chamber ruled that pursuant to Internal Rule 79(4), Judge THOU Mony (reserve) will sit for Judge YOU Ottara until his return.

#### NUON Chea request to follow the hearing from the holding cell

The Trial Chamber granted NUON Chea's request to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

#### KHIEU Samphan motion to adjourn the trial proceedings

The KHIEU Samphan Defence requested additional time to prepare for Case 002/01 appeal hearings and for the upcoming Case 002/02 trial topic on the treatment of the Vietnamese. The Co-Prosecutors responded that this request was not unreasonable but requested that the Trial Chamber hear the three currently scheduled witnesses before adjourning. The Lead Co-Lawyers for Civil Parties did not object to the KHIEU Samphan Defence request but noted the Civil Parties' right for the conclusion of Case 002/02 within a reasonable time.

The Trial Chamber granted the Parties one additional week from the 2 to 5 November 2015 to prepare for Case 002/01 appeal hearings. Because the witnesses originally scheduled for Wednesday and Friday of this week are no longer available, the Trial Chamber will adjourn until 30 November 2015 after hearing currently scheduled witnesses 2-TCW-996 and 2-TCW-868.

# KHIEU Samphan and Co-Prosecutors' request for the Trial Chamber to retract its supplemental order on the use of written records of interview from Cases 003 and 004 (Closed Session)

The KHIEU Samphan Defence asked the Trial Chamber to reconsider its additional guidelines on the use of written records of interview (WRI) from Cases 003 and 004 (E319/7/3), arguing that the guidelines, requiring the proceedings to be held regularly in closed session, deprive the Accused if his right to a public trial. The KHIEU Samphan Defence requested that the Chamber rely only on its original guidelines (E319/7).

The Co-Prosecutors and Lead Co-Lawyers for Civil Parties argued that the Chamber should generally hear witnesses and Civil Parties in public session, absent legitimate security and privacy concerns. The Co-Prosecutors and Lead Co-Lawyers for Civil Parties also argued that the Chamber's original guidelines (E319/7) were sufficient.

The Trial Chamber ruled that its amended guidelines on the use of WRI (E319/7/3) will remain in effect for the time being and that it would hear 2-TCW-996 and 2-TCW-868

entirely in closed session. Each party shall refrain from questioning 2-TCW-868 using Case 003 and 004 WRI until the end of their examination. After consultation with the International Co-Investigating Judge on necessary redactions, the Trial Chamber will make public the redacted transcripts of the 26 October 2015 proceedings. The Chamber's reasoned decision on the request to retract its amended guidelines will be provided in due course.

#### Witness Examination of 2-TCW-996

Trial Chamber and the NUON Chea Defence questioned witness 2-TCW-996.

#### NUON Chea's Internal Rule 87(3) motion

After its questioning of 2-TCW-996, the NUON Chea Defence made a motion to admit D366/7.1.479, a document put to the witness discussing medicines from China. The Trial Chamber granted the motion and admitted D366/7.1.479 into evidence.
