**THE PRE-TRIAL CHAMBER** of the Extraordinary Chambers in the Courts of Cambodia is seised of "MEAS Muth's Appeal Against Co-Investigating Judge Harmon's Decision on MEAS Muth's Motion to Strike the International Co-Prosecutor's Supplementary Submission" (the "Appellant" and the "Appeal", respectively) filed on 31 August 2015.<sup>1</sup>

- On 7 September 2009, the Case 003 judicial investigation was initiated based on the Co-Prosecutors' 20 November 2008 Second Introductory Submission Regarding the Revolutionary Army of Kampuchea,<sup>2</sup> which was signed only by the International Co-Prosecutor.
- On 31 October 2014, the International Co-Prosecutor ("ICP") filed a Supplementary Submission.<sup>3</sup> On 19 November 2014, the Appellant filed the Motion to Strike the Supplementary Submission.<sup>4</sup>
- 3. On 26 November 2014, the International Co-Investigating Judge summoned the Appellant for an initial appearance on 8 December 2014.<sup>5</sup> Upon the Appellant's refusal to attend the initial appearance and the Judicial Police's failure to secure his attendance, the International Co-Investigating Judge charged the Appellant *in absentia* for Crimes against Humanity, violations of the 1956 Cambodian Penal Code and Grave Breaches of the Geneva Conventions of 1949.<sup>6</sup>
- 4. On 3 March 2015, the Appellant filed before the Pre-Trial Chamber ("PTC") an Appeal against the Co-Investigating Judges' constructive denial of his Motion to strike the ICP's Supplementary Submission.<sup>7</sup> Upon recognition of the Appellant's change of status to a

Charged Person, the International Co-Investigating Judge informed, on 26 March 2015, that his earlier submissions were now under consideration.<sup>8</sup>

- 5. On 17 June 2015, the PTC issued a Decision on the Appeal against the Co-Investigating Judges' constructive denial of MEAS Muth's Motion to Strike the ICP's Supplementary Submission, stating, *inter alia*, that the time taken by the Co-Investigating Judges did not amount to a constructive denial of the Motion to Strike and dismissed the appeal as inadmissible.<sup>9</sup>
- 6. On 31 July 2015, His Majesty King Norodom Sihamoni of Cambodia signed the Appointment Letter appointing Judge Bohlander to the Office of International Co-Investigating Judge with immediate effect. Judge Bohlander and Judge Harmon were officially notified of this appointment on 20 August 2015.
- On 5 August 2015, Judge Harmon issued the Decision on MEAS Muth's Motion to Strike the International Co-Prosecutor's Supplementary Submission.<sup>10</sup>
- 8. On 20 August 2015, the Appellant filed a Notice of Appeal.<sup>11</sup> After having filed a Request to the PTC to be permitted to file its Appeal in English with the Khmer translation to follow,<sup>12</sup> the Appeal was filed in English on 31 August 2015 and the Khmer translation followed.<sup>13</sup>
- 9. On 4 September 2015, the Appellant received an email from Filippo de Minicis, Legal Officer in the Office of the Co-Investigating Judges, sent on behalf of International Co-Investigating Judge Bohlander,<sup>14</sup> stating that while acting in good faith, Judge Harmon

issued the Decision on Meas Muth's Motion to Strike the International Co-Prosecutor's Supplementary Submission, without the necessary authority to do so due to his own appointment as International Co-Investigating Judge by His Majesty King Norodom Sihamoni of Cambodia.

- 10. On 11 September 2015, International Co-Investigating Judge issued the Re-Issued Decision on MEAS Muth's Motion to Strike the ICP's Supplementary Submission<sup>15</sup>, which was appealed by the Appellant on 22 September 2015.<sup>16</sup>
- 11. In light of the fact that Co-Investigating Judge Harmon issued the Decision against MEAS Muth's Motion to Strike the ICP's Supplementary Submission<sup>17</sup> without the necessary authority, and that Co-Investigating Judge Bohlander Re-Issued a Decision on MEAS Muth's Motion to Strike the ICP's Supplementary Submission<sup>18</sup>, the Appeal is therefore moot and should be dismissed as such, without determining its admissibility or merits.

#### THEREFORE, THE PRE-TRIAL CHAMBER HEREBY UNANIMOUSLY:

DISMISSES the Appeal as moot.

In accordance with Internal Rule 77(13), there is no possibility to appeal.
