Summary of Proceedings

Opening of hearing and report on attendance of the Parties

The President opened the proceedings and the Greffier informed the Trial Chamber that all Parties were present, with the Accused NUON Chea present in the holding cell.

NUON Chea Defence request to follow the proceedings from the holding cell

The Trial Chamber granted the request of the NUON Chea Defence Team for NUON Chea to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

Submission by Nuon Chea Defence on similarities between Civil Party GA Doeun and PRAK Doeun (2-TCCP-300) in Document E3/4732

The NUON Chea defence makes submissions based on Civil Party PRAK Doeun (2-TCCP-

300) who testified on 3 December, 2015. They ask the Civil Parties Lead Co-Lawyers to disclose information as to whether PRAK Doeun is the same person referred to in document E3/4732, who, contrary to his own testimony, allegedly killed his Vietnamese wife, in order for them to decide to recall PRAK Doeun to provide further clarification This was responded to by the Co-Prosecutors and Trial Chamber. The Civil Parties Lead Co-Lawyers replied that the NUON Chea request has no legal basis unless it is made pursuant to Internal Rule 87(4). They state that the person referred to in document E3/4732 is not PRAK Doeun. They finally submit that they will only respond to an official request in writing by the NUON Chea defence or rely on Chamber's wisdom.

Hearing of Witness [REDACTED] (2-TCW-1000)

The Trial Chamber, Co-prosecutors, and the Civil Party Lead Co-Lawyer questioned the witness 2-TCW-1000. Protective measures in document E319/3 were applied.

NUON Chea Defence objects to submission of Document E3/928 and E3/929 to witness. The NUON Chea Defence objects to showing document E3/928 and E3/929 to witness. The Co-Prosecutors state they are the same documents with different translations. The KHIEU Samphan Defence also objects and submits that the method of showing documents and questioning witnesses in Court has not been followed. The Civil Party Lead Co-Lawyers state the document was already presented to the witness as document E319/23.3.44.3 (E3/928) in which the present document is annexed. The Trial Chamber overrules the objection stating the document and information from the witness is relevant.

Co-Prosecutors do not object to testimony of Mr. Robert Lemkin in Case 002/02

The Co-Prosecutors made clear in a submission that they do not object to the Testimony of Mr. Robert Lemkin in the trial case 002/02.

Co-Prosecutors to email the Trial Chamber about witnesses to be called for the Treatment of the Vietnamese Trial Topic

Co-Prosecutor stated they would have an email sent to the Trial Chamber by the end of 16 December 2015 with a request of the witnesses to be called for the Treatment of the Vietnamese trial topic.
