### Summary of Proceedings

#### Opening of hearing and report on attendance of the Parties

The President opened the proceedings and the Greffier informed the Trial Chamber that all Parties were present. The Accused NUON Chea was present in the holding cell.

### NUON Chea Defence request to follow the proceedings from the holding cell

The Trial Chamber granted the request of NUON Chea to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

# Oral responses to NUON Chea Defence IR 87(4) request to hear an additional witness in relation to Phnom Kraol security centre and to admit that witness's DC-Cam interview

The NUON Chea Defence requested to hear an additional witness in relation to Phnom Kraol Security centre and to admit that witness's DC-Cam interview from 23 March 2007 in response to the Co-Prosecutors' request to hear two additional witnesses for Phnom Kraol security centre in lieu of those witnesses who are now deceased. [Note that there was some confusion as to whether the witness statement was from 2007 or 2001.] The NUON Chea defence submitted that this witness is relevant to events in Mondulkiri and the whole Northeast Zone between 1975 and 1979. The NUON Chea Defence further submitted that the extract of the witness's DC-Cam interview (E3/7960) may not be accurate, and therefore the original DC-Cam record of interview dated 23 March 2007 should be placed on the case file.

The Co-Prosecutors did not object to NUON Chea's requests.

The KHIEU Samphan Defence did not object to the requests by the NUON Chea Defence.

### Hearing of Mr. YSA Osman (2-TCE-95)

The NUON Chea Defence and KHIEU Samphan Defence posed questions to Mr. YSA Osman (2-TCE-95).

Oral ruling on use of questions founded upon information obtained in confessions under torture

The Co-Prosecutors objected to the NUON Chea Defence questioning in respect of confessions obtained at Krouch Chhmar Security Centre on the basis that the NUON Chea Defence had not met the burden of establishing whether the evidence was obtained from torture or not.

The Lead Co-Lawyers for Civil Parties submitted that Decision E350/8 states that "Sessions from S-21 and other security centres carry a real risk that they were obtained by torture" and accordingly, all security centres are covered by the *prima facie* assessment.

Judge Lavergne made an oral ruling that if the aim of the question to the expert is to question him on whether or not torture was practised at Krouch Chmar, this is allowed. However, if the question itself uses information that is liable to have been obtained under torture, such questions are not authorised.

### Request by all parties for additional time to question Mr. YSA Osman (2-TCE-95)

The NUON Chea Defence, KHIEU Samphan Defence and Co-Prosecutors submitted that additional time should be granted to each party for the questioning of Mr. YSA Osman (2-TCE-95). The Trial Chamber granted the Co-Prosecutors one additional session and the two defence teams combined to have an additional half-day.

## Request by the NUON Chea Defence and KHIEU Samphan Defence for closed sessions to question Mr. YSA Osman (2-TCE-95)

The NUON Chea Defence and KHIEU Samphan Defence requested closed sessions for questioning Mr. YSA Osman (2-TCE-95) in the afternoon of 24 March 2016. The Trial Chamber granted this request, which was later withdrawn by the Defence teams.
