Summary of Proceedings

The start of the proceedings was delayed due to A/V Unit technical difficulties.

Opening of hearing and report on attendance of the Parties

The President opened the proceedings and the Greffier informed the Trial Chamber that all Parties were present, with the Accused NUON Chea present in the holding cell.

NUON Chea Defence request to follow the proceedings from the holding cell

The Trial Chamber granted the request of the NUON Chea Defence Team for NUON Chea to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

Oral responses to the International Co-Prosecutor's motion to call a new witness on the treatment of the Vietnamese and to admit related documents (E319/36, paras 11, 12)

The International Co-Prosecutor proposes that the Chamber call an additional witness for treatment of Vietnamese based on information from a recently disclosed OCIJ interview in Case 003and submits that the proposed witness's knowledge on the treatment of the Vietnamese was not discussed in any significant detail in his earlier statement to the Documentation Center of Cambodia. The International Co-Prosecutor submits that the proposed witness can give evidence on treatment of the Vietnamese. The International Co-Prosecutor also proposes admitting into evidence 3 of the 5 written records of interview ("WRI") recently disclosed by the OCIJ. The Civil Party Lead Co-Lawyers support the request to hear this witness and admit the supporting WRI. The NUON Chea Defence team objects to calling the proposed witness but submitted that should the Chamber grant the International Co-Prosecutor's request, it would omit important contextual evidence should it admit the 3 WRI proposed by the International Co-Prosecutor and not the other 2 recently disclosed WRI. The NUON Chea Defence submits that if the Chamber admits the 3 WRI proposed by the International Co-Prosecutor, that all 5 of the proposed witness's WRI should be admitted. The KHIEU Samphan Defence also objects to calling the proposed witness.

Oral responses to the International Co-Prosecutor's request to admit WRI relating to the treatment of the Cham (E319/32)

The International Co-Prosecutor seeks to admit into evidence 25 interviews that relate primarily to the treatment of the Cham, which became available only after the start of the trial. The Lead Co-Lawyers for Civil Parties have no objection to the request. The KHIEU Samphan Defence and NUON Chea Defence both object to the admission of these documents. During these oral responses, the NUON Chea Defence also request a decision on from the Chamber on a pending motion, E370. The KHIEU Samphan Defence requests a decision on its motion, E364. The Trial Chamber noted that it will consider these oral responses in its decision on E319/32.

The Co-Prosecutors, International Lead Co-Lawyer, Trial Chamber and NUON Chea Defence questioned witness (2-TCW-918).
