Summary of Proceedings

Opening of hearing and report on attendance of the Parties

The President opened the proceedings and the Greffier informed the Trial Chamber that all Parties were present, with the Accused NUON Chea present in the holding cell.

NUON Chea Defence request to follow the proceedings from the holding cell

The Trial Chamber granted NUON Chea's request to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

Recognition of Ms. Doreen CHEN before the ECCC as Defence counsel for NUON Chea

Pursuant to Internal Rule 22(2)(a), the President of the Trial Chamber has recognized Ms. Doreen CHEN to practice as defense counsel for NUON Chea before the ECCC and has acknowledged she possesses the same rights and privileges than those granted to National counsels.

Hearing of Witness MAKK Sithim (2-TCW-808)

Questions were put to the witness Mr. MAKK Sithim (2-TCW-808) by the Co-Prosecutors, the Lead Co-Lawyers for Civil Parties, NUON Chea and KHIEU Samphan's Defence.

Decision on NUON Chea Defence request for an adjournment of 4 weeks to prepare for S-21 witnesses and Decision to admit into evidence all documents underlying the new OCIJ prisoners' list (E393.2)

The Chamber is seized of a request by the NUON Chea Defence for an adjournment of four weeks to prepare for the three remaining witnesses on the S-21 topic, namely 2-TCW-906, 2-TCW-816 and 2-TCW-916, primarily to review the documents underlying the S-21 prisoners list produced by the Office of the Co-Investigating Judges (E393.2). Alternatively, it requests that only the Co-Prosecutors and Lead Co-Lawyers question these witnesses prior to an adjournment (E402).

Having heard the parties' submissions and noting that none of them oppose the admission of the documents underlying the new OCIJ prisoners list (E393.3). The Chamber:

- (1) Admits all documents underlying this list that were not previously admitted;
- (2) Considers that the new S-21 list does not require the delay of the testimony of 2-TCW-906 and therefore denies the Defence request in this respect;
- (3) Decides to hear the full testimony of 2-TCW-906 this week as scheduled;
- (4) Further decides to adjourn the hearings for one week (9-12 May) before proceeding to the previously scheduled 13-20 May judicial recess. Upon reconvening on 23 May, the Chamber will hear the remaining S-21 witnesses, 2-TCW-816 and 2-TCW-916 before proceeding to internal purges witnesses and Civil Parties.

The full written reasons for this decision will follow in due course.

Correction to point 3) of oral ruling on NUON Chea request for adjournment

The Chamber issues a correction on point (3) of the ruling and redacts 2-TCW-808 as it was not mentioned in the submissions and is irrelevant.

Hearing of Witness HIM Huy (2-TCW-906)

Mr. HIM Huy 2-TCW-906 was questioned by the International Co-Prosecutor.
