### Summary of Proceedings

#### Opening of hearing and report on attendance of the Parties

The President opened the proceedings and the Greffier informed the Trial Chamber that all Parties were present except counsel Kong Sam Onn, the national counsel for KHIEU Samphan, who was absent for personal matters.

#### NUON Chea request to follow proceedings from the holding cell

The Trial Chamber granted NUON Chea's request to waive his right to be present in the courtroom and to follow the remainder of proceedings from the holding cell.

## Hearing of witness Kaing Guek Eav alias Duch (2-TCW-916)

### Objection by KHIEU Samphan Defence to showing witness a document titled "Decision of the Central Committee-Standing Committee" he did not have prior knowledge of

The KHIEU Samphan defence objected to a question which asked the witness to comment on a document titled "Decision of the Central Committee-Standing Committee" which he did not have knowledge of prior to the investigation for Case 001. They stated that the question was too broad and required the witness to speak as an expert about documents he had not seen which is inappropriate as he is not an expert witness. The Chamber made the oral decision that as the witness is not an expert, he is not in a position to give a general opinion on a document which he had not seen. However, the document may be used to establish knowledge the witness has regarding the manner in which S-21 was called upon to function. Therefore, he instructed that the question should be rephrased.

### Objection by KHIEU Samphan Defence to the inclusion of a statement from a S-21 confession

The KHIEU Samphan defence objected to the content of a confession from S-21 being read out to the witness because the court has previously ruled against doing this as there is a real risk that these confessions were obtained under torture. The co-prosecutor argued that what he was reading was not technically a confession because its contents include a prisoner maintaining his innocence and therefore cannot be classed as a confession made under torture. The chamber rules that it has already found that there is a presumption that any S-21 confession is a result of torture.
