Summary of Proceedings

Opening of hearing and report on attendance of the Parties

The President opened the proceedings and the Greffier informed the Trial Chamber that all Parties were present, with the Accused NUON Chea present in the holding cell.

NUON Chea Defence request to follow the proceedings from the holding cell

The Trial Chamber granted NUON Chea's request to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

Hearing of witness SUOS Thy (2-TCW-816)

The NUON Chea Defence, the Trial Chamber and the KHIEU Samphan Defence completed the questioning of witness SUOS Thy.

Hearing of witness KAING Guek Eav (2-TCW-916)

The Trial Chamber and the Co-Prosecutors questioned witness KAING Guek Eav.

KHIEU Samphan Defence observations on knowledge of the Witness

The KHIEU Samphan Defence raised the issue that testimony given by Duch could be based on information he has gained as a result of his extensive research into the case file by virtue of his position as the Accused in Case 001. It submits that it is important to distinguish between answers Duch gives during his testimony that are based on his observations and experiences for the period in question, and those based on documents he has read since.

The Co-Prosecutors argued that there was no evidence to indicate that the answers Duch had provided thus far were based off books or other material. They stated that due to the nature of his position as head of S-21, Duch was in a position to know vital information, such as the positions held by different people in the Democratic Kampuchea period. They also pointed out that the Defence would have the opportunity to cross-examine the witness.

The NUON Chea Defence agreed with the comments of the KHIEU Samphan Defence.

The Trial Chamber made an oral ruling instructing parties to seek clarification from the witness on the source of his knowledge, as it would be hard to determine when his answers are based on his personal experiences rather than on documents he read.
