#### Summary of Proceedings

#### Opening of the Substantive Hearing

The Trial Chamber declared the opening of the hearing and requested the Greffier to check the attendance of the parties to the hearing. The Greffier confirmed that all parties were present, except Mr. Victor KOPPE, International Defence for NUON Chea was absent for personal reasons. The accused NUON Chea waived his right to be present in the courtroom.

#### NUON Chea Defence request to follow the proceedings from the holding cell

The Trial Chamber granted NUON Chea's request to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

#### Hearing of Civil Party HENG Lai Heang (2-TCCP-251) by Video-Link

The Lead Co-Lawyers for the Civil Parties, Office for the Co-Prosecutor, Defence for NUON Chea, Trial Chamber and Defence for KHIEU Samphan posed questions to Civil Party HENG Lai Heang.

Oral ruling on NUON Chea Defence request under Internal Rule 87(4) to admit four

#### documents into evidence (E416)

The Trial Chamber is seised of an Internal Rule 87(4) request filed by the NUON Chea Defence on 22 June 2016 to admit four documents into evidence, that is Document **E416**. The request seeks to admit the following documents:

- (1) Transcripts of interviews with four anonymous witnesses, conducted by Mr. Robert LEMKIN (2-TCW-877) and Mr. Thet SAMBATH (2-TCW-885) for their film "Enemies of the People" (Document **F2/4/3/3/6.2**);
- (2) Notes written by Mr. LEMKIN related to these interviews (Document F2/4/3/3.1);
  - (3) Mr. LEMKIN's written record of interview before the Supreme Court Chamber (Document F2/4/3/1), and
  - (4) An article published by the *Cambodia Daily Weekend* on 18 June 2016 (Document **E416/3.1.2**)

On 28 June 2016, the Co-Prosecutors filed a response to the request, that is Document E416/1, and the Lead Co-Lawyers filed a response on 4 July 2016, that is Document E416/2. The NUON Chea Defence replied to the Co-Prosecutors' response on 5 July 2016, that is Document E416/3.

Having considered the submissions by the Parties, the Trial Chamber finds that Mr. LEMKIN's written record of interview, Document **F2/4/3/1**, has already been admitted into evidence in Case 002/02 under Document Number **E3/9620**. The request in relation to this document is therefore moot.

With respect to the Transcripts, that is Document F2/4/3/3/6.2, the Chamber admits into evidence only the interview of the witness identified as W2, who is believed to be TOAT Thoeun (2-TCW-829) according to the Supreme Court Chamber decision F2/9. The Chamber therefore admits this excerpt of the Transcripts, that is Document F2/9.2, and assigns it Document Number E3/10665.

The Chamber denies the remainder of the NUON Chea Defence request in its entirety, with written reasons to follow.
