Summary of Proceedings

Opening of hearing and report on attendance of the Parties

The President opened the proceedings and the Greffier informed the Trial Chamber that all Parties were present, with the Accused NUON Chea present in the holding cell.

NUON Chea Defence request to follow the proceedings from the holding cell

The Trial Chamber granted NUON Chea's request to waive his right to be present in courtroom and to follow the proceedings from the holding cell.

Oral Submissions on the request to admit 2-TCE-81's book into Evidence

The Trial Chamber granted the floor to the Parties to provide oral submissions on the Lead Co-Lawyers' request to admit into evidence excerpts from 2-TCE-81's book entitled "Love and Dread in Cambodia". None of the Parties objected to the request and the Co-Prosecutors submitted that the entire book should be admitted. The KHIEU Samphan Defence responded that it was not necessary to admit the entire book.

The Chamber granted the request to admit the entire book and assigned it Document number is E3/10677.

Oral Submissions on the KHIEU Samphan Defence request to admit documents related to 2-TCE-81

The Trial Chamber granted the floor to the parties to provide oral submissions on the request by the KHIEU Samphan Defence to admit into evidence two documents related to 2-TCE-81. During the hearing, the Defence limited its request to admitting only two pages of comments made by the expert (ERNs 01330847 and 01330848). None of the Parties objected to the request.

The Chamber granted the request to admit the two pages and assigned them Document number E3/10676.

Oral Submissions on the NUON Chea Defence request in relation to the questioning of

The Trial Chamber granted the floor to the Parties to provide oral submissions on the request by the NUON Chea Defence on the sequence of questioning of 2- TCW-960. The NUON Chea Defence submitted that it withdraws its request to call 2-TCW-960 as a witness. The Chamber then granted the floor to the Parties to provide oral submissions on the request by the NUON Chea Defence to withdraw 2- TCW-960.

The Chamber issued an oral ruling maintaining its decision to hear 2-TCW-960 as scheduled.
