### Summary of Proceedings

### Opening of hearing and report on attendance of the Parties

The President opened the proceedings. The Greffier informed the Trial Chamber that all Parties were present save for National Co-Counsel for NUON Chea, Mr. LIV Sovanna, who would be absent for the morning session. The Accused NUON Chea was present in the holding cell.

#### NUON Chea Defence request to follow the proceedings from the holding cell

The Trial Chamber granted the request of NUON Chea to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

### Hearing of Witness 2-TCW-850

The Trial Chamber announced pursuant to E319/35, this was a Category A witness and would be referred to by pseudonym. The Trial Chamber, the Co-Prosecutors, the NUON Chea Defence and the KHIEU Samphan Defence questioned to witness 2-TCW-850.

# KHIEU Samphan Defence oral submissions regarding the Lead Co-Lawyer for the Civil Parties' submissions on the scope of the charges of rape E306/7

The KHIEU Samphan Defence requested that the Trial Chamber deliver a Ruling on the scope of Rape charges as a matter of urgency in order to allow the parties to prepare. The Lead Co-Lawyer for the Civil Parties advised the Trial Chamber that its submission sought clarification in relation to the S-21 Security Centre, the Kraing Ta Chan and Tram Kok co-operatives.

### Hearing of Civil Party OM Yoeurn (2-TCCP-274)

The Trial Chamber announced that pursuant to E319/35 the Civil Party is a Category A Civil Party and ought to be referred to by pseudonym. The Legal Officer of the OCIJ later informed the Chamber that categorisation as Category A of the Civil Party was lifted.

The Trial Chamber and the Lead Co-Lawyers posed questions to Civil Party OM Yoeurn (2-TCCP-

274).
