### Summary of Proceedings

### Opening of the Substantive Hearing

The President NIL opened the proceedings and the Greffier informed the Chamber that all parties were present. NUON Chea is present in the holding cell.

### NUON Chea Defence's Request to follow the proceedings from the holding cell

The Trial Chamber granted NUON Chea's request to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

### Hearing of Ms. NGET Chat (2-TCCP-1067)

The Trial Chamber, the Lead Co-Lawyer for the Civil Parties, the Co-Prosecutor, the

NUON Chea Defence and the KHIEU Samphan Defence questioned Civil Party 2-TCCP-1067.

## Objection by the KHIEU Samphan Defence on the line of questioning of the Co-Prosecutor

The KHIEU Samphan Defence objected to the line of questioning of the Co-Prosecutor related to the issue of the Khmer Krom, on the basis that this issue is not part of Case 002/02. The Chamber overruled the objection.

### Objection to a question asked by the Co-Prosecutor to Civil Party 2-TCCP-1067

The NUON Chea Defence objected to a question asked by the Co-Prosecutor to the Civil Party 2-TCCP-1067 on the basis that the Co-Prosecutor was asking the Civil Party to speculate. The Chamber sustained the objection.

### Hearing of SAY Naroeun (2-TCCP-1068)

The Trial Chamber, the Co-Lawyer for the Civil Parties, the Co-Prosecutor, and the NUON Chea Defence questioned Civil Party 2-TCCP-1068.

# Oral Ruling on the Co-Prosecutors' request pursuant to Internal Rules 87(3) and 87(4) to Admit Documents as Evidence

The Chamber notes that the International Co-Prosecutor has filed a request pursuant to Internal Rules 87(3) and 87(4) for the admission into evidence of 8 documents (E319/56). One document sought for admission (E319/56.3.2) is a Written Record of Interview of witness 2-TCW-859 from Case 003, who is scheduled to begin his testimony today.

The Chamber further notes that consolidated responses by the NUON Chea Defence and KHIEU Samphan Defence to the International Co-Prosecutors' 87(3) and 87(4) requests E319/56 and E319/58 were filed on Monday 10 October 2016, in which they do not oppose the admission of E319/56.3.2.

The Trial Chamber recalls its practice to admit into evidence all prior statements of Civil Parties or witnesses who appear before it pursuant to Internal Rules 87(3) and 87(4). It is in the interest of ascertaining the truth that the Chamber and parties have access to all of the statements of Civil Parties and witnesses who will be heard in Case 002/02.

The Chamber therefore admits document E319/56.3.2 into evidence and assigns it Document number E3/10713.

#### Hearing of CHOUN Thy (2-TCW-859)

The Trial Chamber and the KHIEU Samphan Defence questioned Witness 2-TCW-859.
