Summary of Proceedings

Opening of hearing and report on attendance of the Parties

The President YA opened the proceedings and the Greffier informed the Chamber that all parties were present. NUON Chea is present in the holding cell.

NUON Chea Defence Request to follow the proceedings from the holding cell

The Trial Chamber granted NUON Chea's request to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

Observations of the Parties regarding the Hearing of Witness 2-TCW-1002 in Closed Session

The Trial Chamber heard submissions from the Parties regarding the Hearing of Witness 2-TCW-1002 in Closed Session. The Co-Prosecutor did not object to the request that the witness be heard in Closed Session. The Lead Co-Lawyer for the Civil Parties, the NUON Chea Defence and the KHIEU Samphan Defence stated that they had no observations to make. The Trial Chamber stated that it will take a decision in due time.

Oral Ruling on Internal Rules 87(3) and (4) Request by NUON Chea Defence

The Chamber notes that the NUON Chea Defence filed a written request under Internal Rule 87(4) that is, Document E430, on 22 August 2016, for the admission into evidence of four documents. Two of the documents were admitted through an oral decision rendered on 23 August 2016. The Chamber now addresses the remainder of the request in which the NUON Chea Defence seeks to admit excerpts from Document E319/45.4.8, which is the Civil Party application of 2-TCCP-286, who is scheduled to give a statement tomorrow. While Document E430 refers to 2-TCCP-28, it is clear from the other information in the request that the Defence intended to refer to 2-TCCP-286.

The Chamber notes that part of proposed document E319/45.4.8 is already contained within admitted document E3/5010, which is also the Civil Party Application 2-TCCP-286. The excerpts sought for admission by the NUON Chea Defence are additional parts of said Civil Party Application. The Chamber notes that some of the ERN references provided in the request are erroneous and the Chamber therefore relies instead on the excerpts attached to the Defence's filing in rendering its decision.

The Trial Chamber recalls its practice to admit into evidence all prior statements of Civil Parties or witnesses who appear before it pursuant to Internal Rules 87(3) and 87(4). It is in the interest of ascertaining the truth that the Chamber and parties have access to all of the statements of Civil Parties and witnesses who will be heard in Case 002/02.

The Chamber therefore grants the NUON Chea Defence's request to admit into evidence the proposed excerpts of document E319/45.4.11, which are contained at document numbers E430.2 and E430.4. The Chamber assigns these excerpts, combined, Document

Number E3/5010B.

Hearing of Civil Party SENG Soeun (2-TCCP-219)

The Trial Chamber, the Lead Co-Lawyer for the Civil Parties, the Co-Prosecutor and the NUON Chea Defence questioned Civil Party SENG Soeun (2-TCCP-219).

Objection by the NUON Chea Defence to a question asked by the Co-Prosecutor to Civil Party 2-TCCP-219

The NUON Chea Defence objected to a question asked by the Co-Prosecutor to Civil Party 2-TCCP-219, stating that the question was leading the Civil Party. After deliberation, the Judges allowed the Co-Prosecutor to continue his questioning [13:37].

Objection by the KHIEU Samphan Defence to the questioning of Civil Party 2-TCCP-219 by the Co-Prosecutor

The KHIEU Samphan Defence objected to the questioning of Civil Party 2-TCCP-219 by the Co-Prosecutor, arguing that the hearing was straying away from the segment on the Regulation of Marriage. After deliberation, the Judges overruled the objection [13:59].

Objection by the NUON Chea Defence to the question asked by the Co-Prosecutor to Civil Party 2-TCCP-219

The NUON Chea Defence objected to a quotation from document E1/206.1 referred to by the Co-Prosecutor, stating that it was a "totally disingenuous out-of-context quotation of evidence". The Co-Prosecutor responded that he was confronting the Civil Party with evidence that's before the Court. After deliberation, the President overruled the objection and allowed the Co-Prosecutor to proceed with his questioning [14:29].

Objection by the Lead Co-Lawyer for the Civil Parties to the question asked by the NUON Chea Defence to Civil Party 2-TCCP-219

The Lead Co-Lawyer for the Civil Parties objected to a question asked by the NUON Chea Defence stating that it was a leading question. The President asked Counsel for NUON Chea to reformulate his question [15:33].
