Summary of Proceedings

Opening of hearing and report on attendance of the Parties

The President NIL opened the proceedings and the Greffier informed the Chamber that all parties were present.

NUON Chea Defence Request to follow the proceedings from the holding cell

The Trial Chamber granted NUON Chea's request to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

Hearing of Expert 2-TCE-81 (Ms. Peggy Levine)

The KHIEU Samphan Defence, the Trial Chamber and the Co-Prosecutors questioned Expert 2-TCE-81 (Ms. Peggy Levine).

Oral ruling on OCP oral request for extension of time for the questioning of Expert 2-TCE-81

The Co-Prosecutor made an oral request for additional time for all the Parties, to question Expert Ms. Peggy Levine, citing the importance of her testimony for the trial. No objection was made regarding the request.

The Trial Chamber granted the Co-Prosecutor's request and allocated one additional trial session to all Parties for the questioning of the Expert.

Oral ruling on the admission of two documents relevant to the questioning of Expert 2-TCE-81

The Trial Chamber wished to admit two documents provided by Expert 2-TCE-81 and relevant to her testimony into evidence. The parties did not make any objections. The Trial Chamber admitted the two documents into evidence (E310679 and E3/10680).

Oral ruling on the NUON Chea Defence's requests pursuant to Internal Rule 87(4) to admit documents as evidence (E434 and E435)

The Trial Chamber issued an oral ruling on the request presented by the NUON Chea Defence on 30 August 2016 regarding the admission of twenty documents as new evidence (requests E434 and E435). With respect to Document E434, the Trial Chamber admitted Documents 1, 11 and 12 and denied the admission of the other documents and also denied the Co-Prosecutor's request introduced in Document E434/1 to identify and summon the person interviewed in Document 18. With respect to Document E/435, the Trial Chamber admitted document 8 and denied the admission of the remaining documents.
