#### Summary of Proceedings

#### Opening of the Substantive Hearing

The President NIL opened the proceedings and informed the parties that Judge YOU Ottara is absent for urgent personal matters. After deliberation, Judge THOU Mony will take his place until he is able to return to the Bench. The Greffier informed the Chamber that all parties were present. NUON Chea was present in the holding cell.

#### NUON Chea request to follow the proceedings from the holding cell

The Trial Chamber granted NUON Chea's request to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

#### Oral Ruling on the admission of Civil Party Application of 2-TCCP-1063

The Trial Chamber notes that the Civil Party Application of 2-TCCP-1063 is currently classified under document reference number D22/194. The Chamber has recently admitted this Civil Party's Supplementary Information as Document E3/10670 (see E436/1). Another Supplementary Information for this Civil Party was previously admitted as E3/5932a. In line with the Chamber's practice concerning the admission of material relevant to individuals appearing at trial, the Chamber now accordingly admits 2-TCCP-1063's Civil Party Application and assigns document reference number E3/10670a to it.

#### Hearing of Civil Party Ms. KHIEV THEAB Neab (2-TCCP-258)

The Co-Prosecutor and the KHIEU Samphan Defence questioned Civil Party 2-TCCP-258.

# Oral submissions and ruling on the hearing of 2-TCW-1069 during Friday 1 December 2016 afternoon session

The Trial Chamber invited the parties to present their observation on whether or not they would be ready to question witness 2-TCW-1069 during the afternoon session on 1 December 2016. The NUON Chea Defence submitted his readiness to the availability of English translations of DC-Cam interviews of 2-TCW-1069 and 2-TCW-1070 who will be used during the questioning of 2-TCW-1069. The Co-Prosecutor said that he will be ready to hear the questions of the defence but will be ready to ask questions only during the following week and added that it was not reasonable to postpone the hearing if other solutions are available to work on the documents. The KHIEU Samphan Defence said that they will not be ready and that to procede in a state of haste will risks botching their preparations. As the translations of the relevant documents had already been finalised, the Chamber decided to schedule the hearing of witness 2-TCW-1069 during the afternoon session on 1 December 2016.
