### **Unrepresented Civil Parties**

Direction 2

- 1. **THE PRE-TRIAL CHAMBER** of the Extraordinary Chambers in the Courts of Cambodia ("ECCC") notes the Charged Person's Appeals against the Order on Extension of Provisional Detention dated 18 November 2009 ("Appeal").
- 2. On 27 April 2010 the Pre-Trial Chamber scheduled a public hearing for the delivery of its decision on the Appeal on 30 April 2010 at 10:30 advising that a summary of the decision will be read out by the President of the Pre-Trial Chamber. Summons to the Charged Person and his Co-Lawyers were served on the same day.
- 3. On 30 April 2010 the Charged Person and his Co-Lawyers were not present for the hearing for pronouncement of the decision on Appeal.
- 4. The Charged Person had a right to attend, which he did not exercise upon basis that his Co-Lawyers were not available. The Pre-Trial Chamber did not receive any formal application to adjourn the hearing. The Pre-Trial Chamber further notes that the International Co-Lawyer failed, without explanation, to also attend at the hearing on appeal held on 12 February 2010.
- 5. In light of this, the Pre-Trial Chamber reserves the Charged Person's right to make application to be heard upon matters raising from the decision on at least five days notice. Any such notice is to be given within 21 days from this day.
