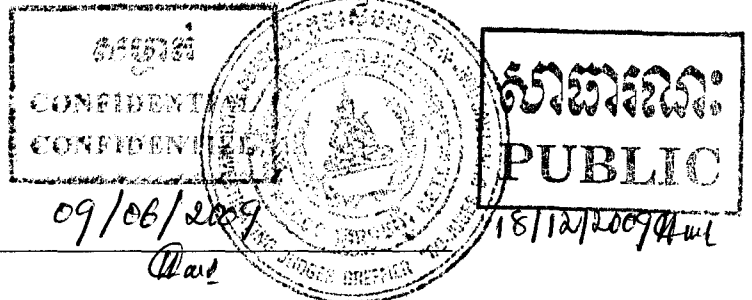




**NOTICE**

1. On 21 May 2009, counsel for Charged Person IENG Sary (the 'Defence') filed its Third Request for Investigative Action (the 'Request')<sup>1</sup> requesting that information relating to (i) the applicable procedural law, (ii) the overall strategy, (iii) the qualifications and experience of OCIJ investigators, and (iv) the collection and analysis of exculpatory evidence by the OCIJ, including alternative theories to those set out in the Introductory Submission, be placed on the case file. The Defence argues that it is squarely within the OCIJ's jurisdiction to take this action because the information requested directly relates to how the OCIJ's factual conclusions ought to be evaluated.
2. Counsel for Charged Person NUON Chea hereby adopts the Request in its entirety.
