INTRODUCTION

- 1- Pursuant to the provisions of the Internal Rules, the *Avocats Sans Frontières France* Civil Party Co-Lawyers Group submits this notice of appeal against the Co-Investigating Judges' Order on the admissibility of civil party applicants from current residents of Ratanakiri province, dated 27 August 2010.
- 2- In the said Order, some civil party applicants were declared admissible while others were declared inadmissible.
- 3- The appeal deals exclusively with those applicants who were declared inadmissible and will concerns the following victims:

Mr KLAN Fit (D220042, 08-VU-001033), Mr ROMAM Yun alias Kamphy (D22/0043, 08-VU-001032), and Ms HEAT Teichov (D220048, 08-VU-001034)

- 4- The appeal is in accordance with the provisions of Internal Rules 23 bis (2), 74(4)(b) and 77 bis.
- 5- The appeal briefs of the appealing parties will be filed with the Pre-Trial Chamber within the prescribed time limits.

- 7- To find their appeal admissible,
- 8- To hold a public hearing and to allow the filing of the additional documents,
- 9- To annul the Order,
