URGENT REQUEST FOR PAGE EXTENSION TO FILE SUBMISSION

1. Pursuant to Internal Rule 77bis(2) of the ECCC's Internal Rules (IR), Court-funded Civil Party lawyers intend to file an expedited appeal on behalf of Civil Party Applicants from Kampong Speu Province ("Appeal").
2. The intended Appeal will exceed the prescribed length of 60 pages in the Khmer language, as will likely be 130 pages, excluding cover pages, references and annexes). Pursuant to Article 5.2 of the *Practice Direction for Filing of Documents before the ECCC*¹.
3. We request that Judges of the Pre-Trial Chamber exercise discretion to grant an extension of the page limit in light of the following exceptional circumstances:
 - a. The Appeal concerns a large number of individual Civil Party applicants: 126 applicants from Kampong Speu are represented in this Appeal.
 - b. It would cause an injustice to the applicants if the substance of the Appeal is limited to 60 pages, forcing applicants to reduce much of the factual and legal substance upon which the appeal is based.
 - c. For these appeals to be heard in the same submission, rather than for each applicant to file separate appeals in order to ease the document management and application examination.
4. Given the expedited nature of this Appeal (to be filed by 17 September 2010), we would be grateful for a response on our request for page extension as soon as possible.
