THE PRE-TRIAL CHAMBER of the Extraordinary Chambers in the Courts of Cambodia ("ECCC") is seized of the "Civil Parties' Request for Extension of Page Limit for Appeal Against Order on the Admissibility of Civil Party Applicants From Kampong Chhnang" ("the Request") dated 14 September 2010.

- 1. In their Request, the Co-Lawyers for the Civil Parties ask the Pre-Trial Chamber to:
 - Exercise discretion to grant an extension of page limit for filing a response to approximately fifty pages in English, excluding cover pages, references and annexes, to enable the Co-Lawyers for the Civil Parties to file an appeal concerning twenty-five civil party applicants;
 - 2) Provide a response to this request given the expedited nature of the forthcoming appeal as soon as possible.
- 2. The Pre-Trial Chamber observes that the Co-Lawyers for the Civil Parties' Request for extension of page limits is made in light of the following exceptional circumstances: 1) the appeal concerns a large number of individual civil party applicants (25); 2) it would cause an injustice to the civil party applicants if, as a result of a limit of thirty pages, applicants are forced to reduce much of the factual and legal substance upon which the appeal is based; and 3) it is ultimately in the best interest of fairness, justice and procedural and logistical efficiency for the twenty-five appeals to be heard in the same submission, rather than for each civil party applicant to file separate appeals.
- 3. The Pre-Trial Chamber considers that the reasons put forward by the Co-Lawyers for the Civil Parties for extension of page limits represent exceptional circumstances within the meaning of the term used in Article 5.4 of the Practice Directions.
