NOTICE OF APPEAL

- 1- The Civil Party Co-Lawyers hereby inform the Co-Investigating Judges that they will appeal the Order on the Admissibility of Civil Party Applicants from the Current Residents of Pursat Province, D423, and in particular in relation to Victim Applicants D22/1082; D22/1085; D22/1132; D22/1561; D22/2940; D22/2941; D22/2943; D22/2958; D22/2959; D22/2962 and D22/2964.
- 2- The Civil Party Co-Lawyers received notice of the Co-Investigating Judges' Order on 15 September 2010, in French and in Khmer. Therefore, this appeal has been filed within the time limit prescribed in Internal Rule 75, i.e. within 10 days from the date on which the Order was received.
- 3- The Civil Party Co-Lawyers will file their appeal brief on 27 September 2010, in compliance with both Internal Rule 77 *bis* (2) on the expedited appeal procedure, which provides that the appeal shall be filed within 10 days of from the date the order on admissibility was received, and with the Co-Investigating Judges' Order.
