 Pursuant to Rule 39(4)(a) of the Internal Rules, counsel for the Accused Nuon Chea (the 'Defence') submit this request to the Pre-Trial Chamber (the 'PTC') for a short extension of time in which to file the Khmer translation of its reply to the 'Co-Prosecutors' Joint Response to Nuon Chea, Ieng Sary, and Ieng Thirith's Appeals Against the Closing Order'.<sup>1</sup> The Interpretation and Translation Unit (the 'ITU') has informed the Defence that it will be unable to complete the final translation by the PTC's deadline.
