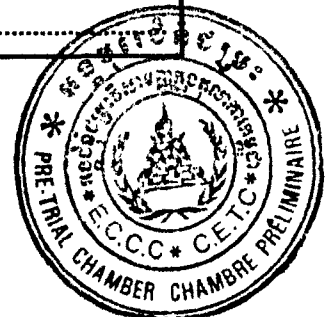

**Unrepresented Civil Parties**

**THE PRE-TRIAL CHAMBER** of the Extraordinary Chambers in the Courts of Cambodia (“ECCC”) is seized of an “Application for Extension of Time to file Ieng Sary’s (the “Charged Person”) Appeal against the [Co-Investigating Judges]’ Order on the Application at the ECCC of the Form of Liability known as Joint Criminal Enterprise”, filed pursuant to Internal Rules 39(4)(a) and 75(3) by the Co-Lawyers for the Charged Person on 17 December 2009 (the “Application”).<sup>1</sup>

1. On 8 December 2009 the Co-Investigating Judges issued an Order on the Application at the ECCC of the Form of Liability known as Joint Criminal Enterprise (the “Order”).<sup>2</sup> The Order was notified on 9 December 2009.
2. On 15 December 2009, the Co-Lawyers for the Charged Person filed a Notice of Appeal against the Order.
3. On 17 December 2009, the Co-Lawyers filed an Application for Extension of Time to file an Appeal. In attached Annex to the Application it is shown that the Co-Prosecutors do not oppose to this request. On 18 December, the Lawyers for the Civil Parties also indicated that they have no objection to the request.
4. By their Request, the Co-Lawyers for the Charged Person request an extension of the time to file an appeal until 22 January 2010.
5. The Pre-Trial Chamber observes that the Co-Lawyers’ Request is made for the following reasons: 1) the issues raised in the appeal are expected to be complex; 2) the period leading up to this deadline includes two international holidays during which time staff members and translators will not be fully available.
6. Pursuant to Internal Rule 39(4)(a), the Pre-Trial Chamber may, at the request of the concerned Party, extend time limits.
7. The Pre-Trial Chamber notes that it is in the interest of the Charged Person to have adequate time and facilities to prepare. The Pre-Trial Chamber further notes that the Request was filed before the time limit expired.
8. The Pre-Trial Chamber is satisfied by the reasons given for the Request and notes the fact that there is no objection by the Co-Prosecutors or the Lawyers for the Civil Parties.
