Mr. IENG Sary, through his Co-Lawyers ("the Defence"), pursuant to Rules 84(1) and 87(3), hereby sets out his objections in the attached Annexes to the admission of certain OCP documents for the first four trial segments, as required by the Trial Chamber in its 25 October 2011 memorandum. The attached Annexes are identical to the annexes listing documents proposed by the OCP with the Defence's objections added in a column to the right for ease of reference. OCP Annexes 7 and 21 are not included in the Defence's objections because Annex 7 is composed of documents which the OCP submitted for the first trial segment and the Defence has already objected to the admission of certain documents in this Annex. Annex 21 is a list of new documents, all of which are already included in the other OCP annexes. The Defence's objections are submitted despite the fact that the Defence has already complied with the Trial Chamber's directions concerning document objections for the first trial segments, which stated that the parties could object to documents by category.² These objections are submitted in order to assist the Trial Chamber to determine the admissibility of specific documents as evidence before it in Case 002/01 and to add further clarity and certainty regarding the Defence's position in relation to individual documents. These objections are submitted subject to the proviso that the Defence is not in a position to assess authenticity. The Defence therefore objects to the admission of any document which is not demonstratively authentic or shown to be authentic by the party seeking to introduce it.

WHEREFORE, for all the reasons stated in the attached Annexes, the Defence respectfully requests the Trial Chamber to REJECT the documents listed in the attached Annexes.
