The Trial Chamber of the Extraordinary Chambers in the Courts of Cambodia;

BEING SEISED of Case File No. 001/18-07-2007-ECCC/TC pursuant to the “Decision on Appeal against the Closing Order Indicting KAING Guek Eav alias Duch,” rendered orally by the Pre-Trial Chamber on 5 December 2008 and filed in Khmer on 9 December 2008;¹

RECALLING the Trial Chamber’s statement, at the conclusion of the hearings on 27 November 2009, that it would duly notify the Parties and the public of the date of pronouncement of the judgement;²

PURSUANT to Internal Rule 98;

HEREBY

NOTIFIES the Parties that the Judgement in Case File No. 001/18-07-2007-ECCC/TC concerning the Accused, KAING Guek Eav alias Duch, will be pronounced on Monday 26 July 2010 in the main courtroom of the ECCC;

INFORMS the Parties that the time of commencement of the hearing will be communicated in due course;
