The President declares the opening of the hearing.



Recognition of Foreign Civil Party Lawyers (Rule 22(2)(a)):

Mr Jasper PAW is introduced by the Cambodian Co-Lawyer and recognised by the Trial Chamber for these proceedings.

Participation of Civil Party Lead Co-Lawyers:

The President indicates that the Civil Party Co-Lead Lawyers are allowed to attend the hearing but have no right to make comments with regards to the applications for release.

Presence of IENG Thirith during the Hearing:

IENG Thirith waives her right to be present during the hearing and indicates that her lawyers will continue to represent her in her absence. She is escorted back to the Detention Facility.

Presence of NUON Chea during the hearing:

NUON Chea feels unwell. His lawyer indicates that he waives his right to be present during the hearing and indicates that his lawyers will continue to represent him in his absence. He is escorted back to the Detention Facility.

Applications for Provisional Release

Each Defence Team presents its oral arguments in support of their respective Applications for Provisional Release and answers two questions of the Trial Chamber. Upon request of the Trial Chamber, each Defence Team also presents additional submissions pursuant to Rule 63(3).

OCP Responses to Applications for Provisional Release and Defence Replies

The Co-Prosecutors present their oral responses to all Defence Applications for Provisional Release. Thereafter, each Defence team is allowed to reply to the Co-Prosecutors responses.

Oral Orders/Decisions:

Order to take the Accused to the Detention Facility.

Orders for Adjournment of Hearing

The hearing is adjourned. Written Decisions on the Defence Applications for Provisional Release will be issued as soon as possible pursuant to Rule 82(3).
