Summary of Proceedings:

Request to read a letter from Civil Parties

Civil Party Group 1 requested the authorisation to read a letter written by 28 Civil Parties. The Chamber instructed the Civil Parties to file their letter in accordance with the applicable procedures.

Questioning of Experts Françoise Sironi-Guilbaud and Ka Sunbaunat

The Defence continued questioning the experts on issues relating to the character of the Accused. The Accused made a few observations on the testimony.

Issues relating to the testimony of character and Defence witnesses

The Co-Prosecutors responded to the requests made by the Defence on 31 August. The Co-Prosecutors did not object to the reading of Henry King's statement, as long as it is placed on the case file and the Co-Prosecutors are provided an opportunity to comment. The Co-Prosecutors did not oppose that witnesses make a spontaneous declaration without questioning. The Co-prosecutors expressed doubt as to the relevance of the video-clip. The Co-Prosecutors considered that the time allocated to Raoul Marc Jennar is sufficient.

Questioning of Witness Sou Sath (D1)

The Chamber, the Co-Prosecutors and the Defence questioned witness Sou Sath on the character of the Accused.

The Defence requested the witness to be granted the right to visit the Accused. The Chamber granted the request.

Questioning of Witness Tep Sem (D2)

The Chamber, the Co-Prosecutors and the Defence questioned witness Tep Sem on the character of the Accused.

Questioning of Witness Tep Sok (D3)

The Chamber, the Co-Prosecutors and the Defence questioned witness Tep Sok on the character of the Accused.

Questioning of Witness Chou Vin (D4)

The Chamber, the Co-Prosecutors and the Defence questioned witness Chou Vin on the character of the Accused.
