Mr. IENG Sary, through his Co-Lawyers ("the Defence"), pursuant to Rule 39(4)(a), hereby requests an extension of time until 15 June 2012 to respond to the Co-Prosecutors' Request for Leave to Provide Assurances with Respect to Non-Prosecution for Witnesses. This Request is made necessary because: a. the OCP's Request raises a number of complex legal issues which merit proper consideration and response; b. the OCP Request was filed at a time when the parties are in the process of examining numerous witnesses; c. the requirement of filing in two languages reduces the period available to draft a response; and d. there are upcoming holidays for national staff on 1 June³ and 4 June⁴ during which time translators will not work. It is respectfully submitted that the normal ten-day time limit to respond to motions⁵ is insufficient in this instance. Recognizing the importance of the issues raised in the OCP Request and the need for its expedited consideration, the Defence requests a modest extension of four days beyond the normal filing deadline.

WHEREFORE, for all the reasons stated herein, the Defence respectfully requests the Trial Chamber to GRANT it an extension of time to respond to the Co-Prosecutors' Request for Leave to Provide Assurances with Respect to Non-Prosecution for Witnesses until 15 June 2012.
