## RESPONSE

- 1. On 15 June 2012 the Defence of Ieng Sary (the 'Defence') filed its Request for a Formal Trial Management Meeting to Discuss the Possibility of Implementing Remote Access to the S-Drive (the 'Request'). The Defence requests that, pursuant to Rule 79(7), the Trial Chamber schedule a formal trial management meeting for the purpose of discussing the possibility of implementing remote access to the S-Drive.
- 2. The Co-Prosecutors support the Defence submission that remote access to the S-Drive would be of great assistance to the work of all parties, both in maximising efficiency and ensuring the security of sensitive file materials. As noted by the Defence, the Co-Prosecutors have previously joined other parties in requesting that the Office of Administration facilitate such access. In addition, the closure of the ECCC Town Office has now made the need for remote access to the S-Drive even more essential to the work of all parties. The considerable commute and the lack of access to amenities outside of business hours make it very difficult for staff to work at the Court on weekends and evenings. This is especially problematic during trial sessions when trial teams appear in Court full-time and continue to prepare for examination outside session times including weekends. The Co-Prosecutors echo the Defence request for implementation of remote access to the S-Drive, and fully support the Defence request for a formal Trial Management Meeting to address any issues arising in this regard.

## RELIEF SOUGHT

3. In light of the foregoing, the Co-Prosecutors request that the Trial Chamber schedule a formal Trial Management Meeting to address this issue as soon as practicable.
