MAY IT PLEASE THE TRIAL CHAMBER

I- INTRODUCTION

- 1. On 19 January 2011, Mr IENG Sary requested the Trial Chamber to conduct the trial through half-day sessions.¹
- 2. As for Mr KHIEU Samphan, he is available to the Court.

II- PURPOSE OF THE REQUEST

- 3. Mr IENG Sary notified the Trial Chamber that he does not wish to make use of video-link technology and indicated that he intends to exercise his right to appear in person at his trial. Mr KHIEU Samphan supports the arguments raised by Mr IENG Sary, and notes that video-link technology is a right of the Accused and cannot be imposed on him.
- 4. For his part, Mr KHIEU Samphan insists on his right to be tried without undue delay.² Having already spent more than three years in provisional detention, Mr KHIEU Samphan would like his trial to be held within the shortest possible time, because the Court must record the finding of his innocence.

FOR THESE REASONS

- 5. It is requested that the Trial Chamber:
 - RECOGNISE Mr KHIEU Samphan's right to appear in person at his own trial
 - NOTE that Mr KHIEU Samphan waives the use of video-link technology
 - NOTE that KHIEU Samphan wishes that his trial be held within a reasonable time
