Of the 15 individuals identified by the Chamber as candidates for withdrawal or deferral in paragraph 5 of the TMM Agenda (E218):

The Co-Prosecutors seek to retain the oral testimony of six (TCW-320, TCW-475, TCCP-186, TCCP-142, TCW-548 and TCW-796), the Lead Co-Lawyers, in addition to supporting the Co-Prosecutors' request to retain TCCP-142 and TCCP-186, of one further individual on this list (TCCP-178) and the retention of one additional Civil Party from a previous list (TCCP-94) and the KHIEU Samphan Defence of four individuals (in addition to two of whom are also sought by the OCP or Lead Co-Lawyers) (TCW-620, TCW-679, TCW-475 and TCW-707).

The proposal to withdraw or defer the testimony of six individuals, namely TCW-638, TCW-354, TCW-780, TCW-234 and TCW-645 was unopposed.

Please note that TCW-536 was inadvertently omitted from paragraph 5 of the TMM Agenda, and the Chamber currently proposes to drop or defer his testimony in relation to the current trial segments. He is, however, under consideration as a potential witness in relation to the population movement trial segments. The Co-Prosecutors support retention of this witness, and the KHIEU Samphan Defence wish him to be heard in the event his work cited in the Closing Order footnotes is admitted into evidence before the Chamber.

2. Invitation to the parties for further suggested reductions to list E131/1.1

The Co-Prosecutors consider that TCW-91, TCW-326, TCCP-94, TCW-126, TCW-724 and TCW-794 need not be heard (opposed by the Lead Co-Lawyers (in relation to TCCP-94)). The IENG Sary Defence propose that TCE-65 and TCE-80 not be called (opposed by the Co-Prosecutors and Lead Co-Lawyers (in relation to both experts) and the KHIEU Samphan Defence (in relation to TCE-65)).

3. Co-Prosecutors' proposal to add seven further individuals to list E131/1.1
