

THE TRIAL CHAMBER of the Extraordinary Chambers in the Courts of Cambodia (“ECCC”);

BEING SEISED of Case File No. 001/18-07-2007-ECCC/TC pursuant to the “Decision on Appeal Against the Closing Order Indicting Kaing Guek Eav Alias Duch,” rendered orally by the Pre-Trial Chamber on 5 December 2008 and filed in Khmer on 9 December 2008;

NOTING that Witness TC1, namely Mr. François Bizot, during his interview with the Office of the Co-Investigating Judges indicated that in 1971 he received from the Accused an envelope addressed to the French Embassy containing a document entitled “Political Programme of the United National Front of Kampuchea”;¹

HEREBY:

REQUESTS the Office of the Co-Investigating Judges to indicate, within 3 days from the receipt of the present Request, whether they have conducted any investigations at the French Foreign Ministry to retrieve the aforementioned document and, in case they are in possession of it, to transmit to the Trial Chamber a copy of the document and of any other material relevant thereto. *Handwritten initials*
